Question 1:Do you agree with the proposal to include, as a matter of course, the 470 kHz and 5 MHz bands into the Licence for all Amateur Radio (Full) licensees?:

Yes but with reservations.

The bands should bemade available under the conditions pertaining to other bands available on a Secondary Basis.

The present Clause 13 is generally fit for purpose but 13b could be replaced by a requirement to transmit the callsign in such a way that the station is clearly identifiable at all times.. This would imply frequent transmission of callsigns throughout and at the beginning and end of a QSO.

Question 7: Given the current uncertainty amongst Radio Amateur licensees in relation to Clause 2(2), do you believe that it would be a practical solution for Ofcom to remove this Clause and to insert additional wording into Clause 13, as proposed above?:

No. The current practice does not need to change. Such a change would create considerable confusion.

No The callsigns of intermediate licence holders should be treated in the same way as other callsign classes.
