**Question 1:Do you agree with the proposal to include, as a matter of course, the 470 kHz and 5 MHz bands into the Licence for all Amateur Radio (Full) licensees?:**

No - Not as proposed. I think that the bands should be available to all Full Licencees the same way as other bands to which amateurs have access on a Secondary basis. The standard wording applicable to other amateur bands should suffice i.e:

"Secondary. Available on the basis of non-interference to other services inside and outside the UK"

Also, the Paragraph 2.26.6, as well as the phrase 'electronic equipment' in 2.26.3 should not be included. The existing regulations are sufficient without bringing in vague sections about "electronic equipment".
