**Question 1:Do you agree with the proposal to include, as a matter of course, the 470 kHz and 5 MHz bands into the Licence for all Amateur Radio (Full) licensees?:**

Not entirely - I do agree that the bands should be included in the Full Licence, the current NoV situation does seem like wasted effort if it was automatically granted on application.

I don't agree with the new addition in 2.26.3 where interference caused to 'electronic equipment' is stated. This is not part of the current licence for the lower LF band or any other higher bands, I don't see any reason for it to be added here and not for the others.

**Question 2:Do you agree that expressly linking a Full (Club) Licensee's authorisation to use the spectrum to his or her representation of a named club, and by adding a further ground for revoking the Licence to include circumstances where the licensee no longer represents the club, will help ensure that a club's call sign remains with the club?:**
