In general I welcome the proposed changes; however, I do have concerns over the simplified guidance for Maritime Mobile operation which requires careful planning and control outside UK waters. I write as a Yacht Master who regularly sails in Central American and other waters.

- 2.89 is very complex; the term At Sea may be interpreted in a number of ways, especially when inside sovereign territorial waters of a CEPT or Non CEPT country and specifically inside the territorial waters of a country with no reciprocal arrangements with the UK. Specifically operating within the confines of or the vicinity of a port without the agreement of or license from the appropriate sovereign state. Perhaps this clause relates solely to UK stations being operated within UK territorial waters.
