No. The assumption that individual Radio Amateurs are best placed to decide how to go about identifying their stations is questionable. If left to individuals, a wide scale variance in practice will follow to the detriment of the quality of operating procedure. Routine confirmation of call signs at a minimum of 15 minute periods and more often than not after each transmission, has become best practice within amateur service and distinguishes licences amateurs from 'casual' users of licence exempt services.

Question 7: Given the current uncertainty amongst Radio Amateur licensees in relation to Clause 2(2), do you believe that it would be a practical solution for Ofcom to remove this Clause and to insert additional wording into Clause 13, as proposed above?:

Additional wording should propose variations to the existing conditions only to allow for modes of operation where the 15 minute stipulate may not be feasible or practical

Question 8:Do you agree with Ofcom?s proposal to amend Clause 2(3) of the Licence to require Intermediate licensees to transmit a call sign that reflects the location of their main station?:

No. The current location of an transmitting station is more important than it's registered station address.

To avoid uncertainties over identifying location, callsigns should reflect the current location of the transmitting station. Anys intermediate licences containing an RSL should be modified by OFCOM to accommodate this operational consistency.
