Question 8:Do you agree with Ofcom's proposal to amend Clause 2(3) of the Licence to require Intermediate licensees to transmit a call sign that reflects the location of their main station?:

Yes but will this identifier remain constant? e.g. A Northern Irish 2i0xxx call operates in England, will he still identify as 2i0xxx or change to 2e0xxx? This needs to be made clear. Ideally he would identify as the 2i0xxx all regardless of current location

Question 9:Do you agree that replacing Clauses 2(1) and 16(1) with a new Clause to simplify and bring together all of the licence conditions relating to the operation of radio equipment away from the Main Station address will make these provisions clearer?:

Yes, but need to clarify about "repeater" as to whether it includes fixed repeaters or only temporary repeaters set up by/for raynet use.
