Why change something that has worked for years?

Question 1:Do you agree with the proposal to include, as a matter of course, the 470 kHz and 5 MHz bands into the Licence for all Amateur Radio (Full) licensees?:

Yes. It would save both OFCOM and amateurs a lot of time spent in applying for and issuing NOV's.

I have heard several continental stations refuse to answer 2E0 calls because they consider the callers to be pirates because they say 2E"Oh" instead of 2Ezero. That causes confusion. Clubs and other amateurs should police this problem ourselves.

Question 7: Given the current uncertainty amongst Radio Amateur licensees in relation to Clause 2(2), do you believe that it would be a practical solution for Ofcom to remove this Clause and to insert additional wording into Clause 13, as proposed above?:

No. Correct tuition should obviate the necessity to legislate this extra requirement.

Question 8:Do you agree with Ofcom?s proposal to amend Clause 2(3) of the Licence to require Intermediate licensees to transmit a call sign that reflects the location of their main station?:

Absolutely not. Why should they be discriminated against like that? They are taught to give locators in QSO's, although in my experience many are wary of giving specific locations available to burglars with scanners or unscrupulous amateurs who exist in our community. This is why some amateurs resist having locations published in RSGB yearbook and on QRZ.Com. We often hear unguarded remarks from amateurs giving full details of valuable equipment in use at the station, followed by & amp; amp; quot; Don't call me for two weeks as I shall be abroad on holiday.

We must remember that includuing locations helps thieves.
