Question 1:Do you agree with the proposal to include, as a matter of course, the 470 kHz and 5 MHz bands into the Licence for all Amateur Radio (Full) licensees?:

With caveats, I support the idea of opening these bands up to Full Licensees.

1) There is however a prospective problem in the proposed reference to "electronic equipment". It has been the accepted view for many years that, if EMC problems arise with non-radio electronic systems, the fault Is unlikely to lie with the radio amateur. If the proposed clause were inserted in its present form, it might in effect open the floodgates to the use of non-radio equipment that is "poorly designed, constructed, maintained or used", with the risk of generating a significant number of complaints.

2) If radio amateurs are to be required to estimate or measure RF fields, it is essential that any methods specified are clearly laid down and feasible for the ordinary licensee to use.

The existing system has stood the test of time. The only amendment I would suggest would be to omit reference to specific transmission modes and simply refer to a modulation format consistent with that in use.

The existing practice has worked well for many years. There would seem to be no great reason to change it ("if it ain't broke, don't fix it").
