**Question 1:Do you agree with the proposal to include, as a matter of course, the 470 kHz and 5 MHz bands into the Licence for all Amateur Radio (Full) licensees?:**

No - I believe the restriction on airborne operation should be removed entirely. Use in high altitude ballooning and amateur rocketry would be a valuable extension to the licence and bring in many more people into Amateur Radio through those activities.

Airborne operation within the ham radio licence is allowed in many countries - and I see no reason not to allow it here. OFCOM have provided no explanation of why it is not allowed in the UK - particularly in the primary bands.
