Question 1:Do you agree with the proposal to include, as a matter of course, the 470 kHz and 5 MHz bands into the Licence for all Amateur Radio (Full) licensees?:

Yes, but reference to interference to "electronic equipment" should be deleted. We accept we should not interfere with primary users of radio services but are concerned about accusations of interference with unspecified equipment.

Question 2:Do you agree that expressly linking a Full (Club) Licensee?s authorisation to use the spectrum to his or her representation of a named

club, and by adding a further ground for revoking the Licence to include circumstances where the licensee no longer represents the club, will help ensure that a club?s call sign remains with the club?:

Yes, providing measures are taken to ensure clubs keep up to date information about the responsible club officers with Ofcom so that a licence can be revoked and then transferred to a new club holder efficiently and avoid extended dispute.
