When operating in a location in the UK including at the main station address, the call-sign should be modified by the Regional Secondary Locator immediately after the G or M. In the form

[Except when operating in England, which has no RSL.]

When operating at a location other than the Main Station Address, the call-sign should be modified by a suffix to show the nature of this different location, in the form
