Question 1:Do you agree with the proposal to include, as a matter of course,

licensees?:

Not as proposed. I agree that the proposal to include 470kHz and 5 MHz to UK Full licensees is great for the hobby, following the standard wording "Secondary. Available on the basis of non-interference to other services inside and outside the UK".

Of concern to me is Paragraph 2.26.6, which should be omitted entirely, as well as the phrase 'electronic equipment' in 2.26.3. These clauses have the ability to change the hobby entirely, and have not been required before.

Question 2:Do you agree that expressly linking a Full (Club) Licensee?s authorisation to use the spectrum to his or her representation of a named club, and by adding a further ground for revoking the Licence to include circumstances where the licensee no longer represents the club, will help ensure that a club?s call sign remains with the club?:

No. I believe that clear and precise rules exist with regard to callsign use. The use of specific modes in licensing conditions is unwelcome. Keep the license without loss of generality. Changes would not apply on 5MHz, so this seems to be a more confusing and backward step.

Question 7: Given the current uncertainty amongst Radio Amateur licensees in relation to Clause 2(2), do you believe that it would be a practical solution for Ofcom to remove this Clause and to insert additional wording into Clause 13, as proposed above?:

No. This is a widely accepted practice world-wide. I do not believe the alleged confusion exists in quantities enough to warrant change.

Question 8:Do you agree with Ofcom?s proposal to amend Clause 2(3) of the Licence to require Intermediate licensees to transmit a call sign that reflects the location of their main station?:

No. All licenses should be subject to the same (current) clause.

Question 9:Do you agree that replacing Clauses 2(1) and 16(1) with a new Clause to simplify and bring together all of the licence conditions relating to the operation of radio equipment away from the Main Station address will make these provisions clearer?:

Yes. There does seem to be some confusion around this.
