for emergency cut-downs or shutdown of transmitters.

Furthermore, to clarify whether the use of an Amateur Radio Callsign is permitted to be used as the identifying callsign of a payload which at the moment is a very grey area due to it's airborne nature, despite HABs using licence exempt transmitters falling in the ISM parts of Amateur bands.

Additionally, I would like to see the licence cover the whole gamut of HAB experimentation, including permitting airborne use. Perhaps with an upper power limit of 100mW within either the standing ISM bands or other part of the Amateur bands (likely 70cms).
