Yes. I agree this will have no immediate impact on fees and any changes the powers that be wish for in the future will happen regardless so the wording may as well be consistent.

Question 6:Do you agree that Clause 13 of the Licence should be amended to allow for a simpler, more flexible approach for identifying Amateur Radio stations?:

Yes. The amateur service should be able to do the correct thing without it being spelt out and this may be beneficial for future modes where call signs can be given in sub channels etc.

Question 7:Given the current uncertainty amongst Radio Amateur licensees in relation to Clause 2(2), do you believe that it would be a practical solution for Ofcom to remove this Clause and to insert additional wording into Clause 13, as proposed above?:

Yes. Given what you say in 2.68 was your intentions then 2(2) is clearly confusing. That said if you simply removed the clause then it would read to me the end of using the RSL at all as 17(1)(ee) would appear to rely on it.

Perhaps the best thing would be for Ofcom to actually spell out exactly what they mean and put that in the license.

Question 8:Do you agree with Ofcom?s proposal to amend Clause 2(3) of the Licence to require Intermediate licensees to transmit a call sign that reflects the location of their main station?:

Yes. It appears to be the only course of action to cope with licenses already issued and the law as it stands.

Question 9:Do you agree that replacing Clauses 2(1) and 16(1) with a new Clause to simplify and bring together all of the licence conditions relating to the operation of radio equipment away from the Main Station address will make these provisions clearer?:

Question 10:Do you agree that the proposed changes will clarify RAYNET operation under the Licence?:

Yes. The role of amateur radio in emergency communication is probably shrinking as other communication systems become more reliable and ubiquitous. It still has some unique properties however and for the benefit of society as a whole these should be allowed to be used as often as needed.

I do wonder if the definition of the user services should be expanded to catch public service events that aren't necessarily emergency oriented (but are non-profit and for the benefit of the public). This would be to ensure there are enough practise opportunities to keep people trained, without having to stretch any definitions. That may be a bit off topic for this question however.
