Question 1:Do you agree with the proposal to include, as a matter of course, the 470 kHz and 5 MHz bands into the Licence for all Amateur Radio (Full) licensees?:

Yes, but on the same basis as other Secondary bands. I feel the standard "Available on the basis of non-interference to other services etc" condition would suffice.

Para 2.26.3, once the precedent is set, could be applied to other bands, with the effect that interference to amateur transmissions becomes wholly the amateur's problem, no matter what "electronic equipment" is the cause,

Question 2:Do you agree that expressly linking a Full (Club) Licensee?s authorisation to use the spectrum to his or her representation of a named club, and by adding a further ground for revoking the Licence to include circumstances where the licensee no longer represents the club, will help ensure that a club?s call sign remains with the club?:

Question 7: Given the current uncertainty amongst Radio Amateur licensees in relation to Clause 2(2), do you believe that it would be a practical solution for Ofcom to remove this Clause and to insert additional wording into Clause 13, as proposed above?: No.

The use of regional identifiers is well known. I believe, however, that the inclusion of the regional identifier in the licence document can cause confusion. (or should I really be using MMM0DEC in Sctland?? :-))

Question 8:Do you agree with Ofcom?s proposal to amend Clause 2(3) of the Licence to require Intermediate licensees to transmit a call sign that reflects the location of their main station?:

No.

The regional idenifier should, IMO, reflect the location, not the home address.

While I recognise the problem caused by the Intermediate Licence format, I do not think the solution lies in changing the use of the secondary locator.

Question 9:Do you agree that replacing Clauses 2(1) and 16(1) with a new Clause to simplify and bring together all of the licence conditions relating to the operation of radio equipment away from the Main Station address will make these provisions clearer?:
