Additional comments:

On the whole, the proposals are sensible. However the proposals to remove the requirement to use appropriate regional prefixes is causing consternation in the UK amateur fraternity. Regional prefixes identify the country or entity from which a radio amateur is operating - SP is Poland, DL is Germany, etc. The UK prefixes, GM, GJ, GU, GW, GD, G, and occasionally GZ for Shetland, are internationally known and recognised. These prefixes are particularly important in the context of international (DX) operation and in competition. The international amateur radio community want to be able to identify the country of operation immediately on initial (CQ) call. Please do not change the existing wording of UK licences in the area of regional prefixes.
