For suffixes there should be a requirement that whatever is chosen by an operator should make absolutely clear the status of the station, whether, portable, mobile, pedestrian mobile, maritime mobile, alternative main station (not 'fixed portable' - it is too ambiguous), remotely operated. CEPT visitors should use country and RSLs strictly as prefixes separated by '/' pronounced as 'stroke' and not as 'slant' or 'slash'. Again if Ofcom does not wish to retain responsibility for this it should be handed explicitly to IARU/RSGB.

Clause 13 should be modified to reflect this if Clause 2.2 is removed.
