Question 1:Do you agree with the proposal to include, as a matter of course, the 470 kHz and 5 MHz bands into the Licence for all Amateur Radio (Full) licensees?:

Not as you have suggested. The bands should be made available to all full licencees but in the same way as other secondary basis bands that amateurs have access to. The standard wording applicable to other bands should be applied.

Para 2.26.6 should be omitted entirely as should the phrase electronic equipment in 2.26.3 as otherwise these form a precedent changing the licensing basis.

Question 2:Do you agree that expressly linking a Full (Club) Licensee?s authorisation to use the spectrum to his or her representation of a named

club, and by adding a further ground for revoking the Licence to include circumstances where the licensee no longer represents the club, will help ensure that a club's call sign remains with the club?:

Not as proposed. A clear definition with the standard 15 minute limit should be retained. Identification appropriate for the modulation in use should be retained without specific mention of modes.

Question 7:Given the current uncertainty amongst Radio Amateur licensees in relation to Clause 2(2), do you believe that it would be a practical solution for Ofcom to remove this Clause and to insert additional wording into Clause 13, as proposed above?:

The present locator indicator system should be retained. The uncertainty has arisen in Ofcom's own piecemeal introduction of changes, whereas licensees have been clear and need to avoid any ambiguity the proposed changes will bring
