We feel that the optional use of Regional Secondary Locators is fatally flawed. It will make life on the air VERY difficult for those who are chasing DXCC and other awards, which consider Scotland and Wales as separate countries. It will also be difficult to tell from where a given station is operating which will be confusing to newcomers - the lifeblood of the next generation of radio amateurs!

Secondly, it is commonplace (unfortunately) for many stations NOT to identify every 15 minutes, and we would be horrified at the prospect of effectively retrospectively approving this situation in law. The existing rules are fine. We can envisage the situation where a particular station is "hogging" a local repeater or internet gateway with no identification

except at the start of transmission (which if missed will make it impossible to identify that station in order to report him or her to the Amateur Radio Observation Service of the RSGB or yourselves.
