Question 1:Do you agree with the proposal to include, as a matter of course, the 470 kHz and 5 MHz bands into the Licence for all Amateur Radio (Full) licensees?:

NO. The proposal is ambiguous and open to interpretation. Furthermore the current rule works quite satisfactorily and does not need changing.

Question 7: Given the current uncertainty amongst Radio Amateur licensees in relation to Clause 2(2), do you believe that it would be a practical solution for Ofcom to remove this Clause and to insert additional wording into Clause 13, as proposed above?:

NO! The regional identifier is fundamental to many aspects of world-wide amateur radio e.g. country awards and contesting - it is very important that the station being contacted immediately knows the country that the UK based station is in. The current system works fine and I am not aware of any experienced radio amateur having any problems with it.

I don't understand why there is confusion over clause 2.2 - the word 'shall' in the sentence clearly defines the obligation to use the RSL.

On the second issue - yes, if a station was travelling from country to country then they would have a variety of prefixes. Each prefix denotes the country that they're operating in - the system works fine.

If RSLs MUST be dropped, then it should be obligatory to use the CEPT style country prefix when travelling to another UK country e.g. English station G4IRN becomes MM/G4IRN when operating from Scotland. This is how we all have to operate when travelling to other CEPT countries, so might make more sense to adopt here.

I suggest that rather than changing the rules due to possible confusion, the rules are reworded to confirm and clarify the current regime as it is widely understood.

Question 8:Do you agree with Ofcom?s proposal to amend Clause 2(3) of the Licence to require Intermediate licensees to transmit a call sign that reflects the location of their main station?:

NO - for the same reasons as above.
