**Question 10: Do you agree that the proposed changes will clarify RAYNET operation under the Licence?:**

Proposed changes are good, but I query the use of the word 'RAYNET' - the current licence does not differentiate between Amateur's ability to support emergency comms between being a member of RAYNET or not - and definition of 'RAYNET' could be 'interesting' as not all groups are members of the 'Network'. Similarly some Amateurs operate in emergencies as individuals or on behalf of other groups such as 4x4 Response, whose primary purpose is not communications but still support User Services.

Recent changes to the Bandplan replaced the phrase 'may be used by RAYNET' with 'may be used for Emergency Communications and Community Events'
