Additional comments:

Special event callsign using the GB prefix do not identify the country being operated from. I suggest that this could be changed, outside England. to using a prefix such as GBW or GBJ if a 3 character prefix is permissible unless there is a better option.

An apparent error in the wording of the license is on page 13 section (oo) where countries outside the UK seem to be identified as being in the UK. I understand that the correct term for the complete area for which the licences are administered is the "British Islands" which is defined in the Interpretation act 1978. Alternatively it could say "UK and Crown Dependencies".

Dear Sir,

I have already submitted my response to the Consultation Paper on Amateur Radio licensing. I would like to add some more details for you to consider as some of them were not covered in the paper.

I would like to see a correction to section (oo) on page 13 of the license. This gives an incorrect meaning to the United Kingdom which consists of Great Britain and Northern Ireland. The Isle of Man and the Bailiwicks of Guernsey and Jersey are the Crown Dependencies which are not part of the UK. I understand that the correct term to use is the British Islands as defined in the Interpretation Act 1978.

According to Section 5 of the Interpretation Act 1978 - "British Islands" means the United Kingdom, the Channel Islands and the Isle of Man. This definition is distinct from that of the British Isles that is geographic and includes the Republic of Ireland. From the Act of Union on 1 January 1801 until 6 December 1922, the island of Ireland was part of the United Kingdom of Great Britain and Ireland. As far as I know the Crown Dependencies have never been part of the United Kingdom. As I live in Jersey the term British Islands is used on my passport.

Perhaps the definition of the areas covered by the Ofcom licenses given near the top of the first page of the license could also be improved as it could be interpreted in more than one way and suggests that the Crown Dependencies are part of the UK.

Since the Consultation Paper was published I have heard that the prefix GK is likely to be available to Radio Amateurs in Cornwall. This sounds like a very good idea as anything that gives more information about where a station is located is useful. Most of my operation is now on the VHF and UHF bands and hearing that prefix would allow me to point my antennas in that direction. It would also be useful for other regions of England to have their own regional identifiers, maybe GL for London, although they would have to be for groups of counties otherwise there would not be enough remaining letters. Also it would not be helpful to allow us to use our home station prefix when operating in other countries or areas covered by the license.

It is always considered important for the prefix of the callsign to indicate which country, or part of the country, that the station is operating from. One exception to this is the GB prefix as used for special event stations, beacons and repeaters. In my opinion this should be improved in order to remove the confusion. One possibility would be to use a 3 letter prefix, if that is permissible, such as GBW or GBM or GBJ or GBK etc.

That would be much better than the equivalent CEPT use which would be to prefix the callsign with M/- which could be confused with operating mobile.
