

A7. Statutory Notification: Modification of Designated Universal Service Provider Condition 1 (the “Notification”)

Notification of modifications to Designated Universal Service Provider Condition 1 pursuant to section 36 of, and in accordance with section 53 of, and Schedule 6 to, the Postal Services Act 2011

Background

- A7.1 On 1 October 2011, responsibility for postal regulation transferred to Ofcom under the Postal Services Act 2011 (the “Act”). Ofcom subsequently imposed on Royal Mail, as the designated universal service provider, certain designated universal service provider conditions to make provision for matters set out in sections 36 and 37 of the Act. These included Designated Universal Service Provider Condition 1 (“DUSP 1”), which specifies the services that Royal Mail must provide as part of the universal service. Ofcom subsequently modified DUSP 1.^{1 2} The current condition has been in force since 1 March 2017 (the “Existing DUSP 1”).^{3 4}
- A7.2 On 24 January 2024, Ofcom published a Call for Input (“CFI”) titled ‘*The future of the universal postal service*’,⁵ setting out evidence that suggests the universal service needs to change to better align with the needs of consumers and to ensure it can continue to be affordable and sustainable in the future. Ofcom sought input from all interested parties to generate an informed public debate on how the universal service should be modernised for the future.
- A7.3 On 5 September 2024, Ofcom published the document ‘*Future of the universal postal service - Summary of responses to our Call for Input and next steps*’⁶ that summarised the responses received to the CFI.
- A7.4 On 30 January 2025, Ofcom published a consultation entitled ‘*Review of the universal postal service and other postal regulation*’, which included at Annex 8 a notification of

Ofcom's proposals to modify DUSP 1 (the "**January 2025 Notification**"). A copy of the January 2025 Notification was sent to the Secretary of State, in accordance with paragraph 5(1)(a) of Schedule 6 to the Act.

- A7.5 Ofcom invited representations about the proposals set out in the January 2025 Notification by 10 April 2025. Ofcom received responses from 7,072 stakeholders, and considered every such response in reaching the decisions set out below. In accordance with paragraph 3(5) of Schedule 6 to the Act, Ofcom has made the decisions set out below to give effect to its proposals set out in the January 2025 Notification, with some modifications (the nature of which are explained in the accompanying statement). The Secretary of State has not notified Ofcom of any international obligation of the United Kingdom for the purpose of Ofcom giving effect to those proposals.

Decisions

- A7.6 Ofcom hereby decides, in accordance with section 53 of, and Schedule 6 to, the Act, and pursuant to its powers under section 36 of the Act, to make modifications to the Existing DUSP 1.
- A7.7 The modifications to the Existing DUSP 1 are specified in the Schedules to this Notification:
- a) Schedule 1 is marked up against the Existing DUSP 1 to show the changes which are being made to its substance. Additions are shown in red text and yellow highlight. Deletions are shown in struck through text and yellow highlight.
 - b) To ensure accessibility, Schedule 2 contains a table setting out the modifications.
For the avoidance of doubt, the modifications contained in each Schedule are identical.
- A7.8 All modifications save for those referred to in paragraph A7.9 below will take effect on 28 July 2025. A clean version of the modified DUSP 1 (i.e. without any markings) will be uploaded to Ofcom's website on that date.
- A7.9 The following modifications in Table 1 under 'Domestic end-to-end services' will take effect on 1 April 2026:
- a) The modification of the performance target for 'USO priority services: services provided pursuant to DUSP 1.6.1(a) deemed delivered with an actual routing time of D+1' from 93.0% to 90.0%.
 - b) The insertion of the new row relating to the standard 'USO priority services: services provided pursuant to DUSP 1.6.1(a) deemed delivered with an actual routing time of D+3.'
 - c) The modification of the performance target for 'USO priority services provided pursuant to DUSP 1.6.1(a), purchased by postage stamp and by meter: deemed delivered with an actual routing time of D+1 in each postcode area apart from HS, KW and ZE' from 91.5% to 87.0%.
 - d) The modification of the performance target for 'USO standard services provided pursuant to DUSP 1.6.1(b): deemed delivered with an actual routing time of D+3' from 98.5% to 95.0%.
 - e) The insertion of the new row relating to the standard 'USO standard services provided pursuant to DUSP 1.6.1(b) deemed delivered with an actual routing time of D+5'.

A7.10 The effect of, and Ofcom’s reasons for making, these modifications are set out in the accompanying statement.

Ofcom’s duties and legal tests

A7.11 Ofcom is satisfied that these modifications satisfy the general test in paragraph 1 of Schedule 6 to the Act.

A7.12 In making these modifications, Ofcom has also considered and acted in accordance with its duties under the Act, including its duty in section 29, and its general duties in the Communications Act 2003, including those in section 3.

A7.13 A copy of this Notification and the accompanying statement have been sent to the Secretary of State in accordance with paragraph 5(1)(a) of Schedule 6 to the Act and section 24A(1) of the Communications Act 2003.

Interpretation

A7.14 Except insofar as the context otherwise requires, words or expressions shall have the meaning assigned to them in this Notification and otherwise any word or expression shall have the same meaning as it has been ascribed for the purpose of Part 3 of the Act or for the purpose of the USP access condition (as relevant).

A7.15 In this Notification—

- a) “**Act**” means the Postal Services Act 2011 (c.5);
- b) “**CFI**” means Ofcom’s Call for Input (“**CFI**”) titled ‘*The future of the universal postal service*’, published on 24 January 2024;
- c) “**DUSP 1**” means the Designated Universal Service Provider access condition referred to at paragraph A7.1 of this Notification;
- d) “**Existing DUSP 1**” means the version of DUSP 1 in force as of 1 March 2017;
- e) “**January 2025 Notification**” means the statutory notification of the modifications Ofcom proposed to make to Existing DUSP 1, published on 30 January 2025;
- f) “**Ofcom**” means the Office of Communications; and
- g) “**Royal Mail**” means Royal Mail Group Ltd, whose registered company number in England and Wales is 04138203, which is the current universal service provider for the purposes of section 38 of the Act.

A7.16 For the purpose of interpreting this Notification—

- a) headings and titles shall be disregarded;
- b) expressions cognate with those referred to in this Notification shall be construed accordingly; and
- c) the Interpretation Act 1978 (c. 30) shall apply as if this Notification were an Act of Parliament.

SERVICES, ACCESS POINTS, PERFORMANCE TARGETS, NOTIFICATION AND PUBLICATION AND CONTINGENCY PLANNING

1.1. Application, definitions and interpretation

<p>DUSP 1.1.1</p>	<p>This Designated USP condition (“DUSP Condition”) shall apply to the <u>universal service provider</u>.</p>
<p>DUSP 1.1.2</p>	<p>In this DUSP Condition—</p> <p>(a) “Act” means the Postal Services Act 2011 (c.5);</p> <p>(b) “actual routing time” means the period in <u>working days</u>, between the <u>deemed date of collection</u> of a <u>postal packet</u> and the <u>deemed delivery date</u> of that packet;</p> <p>(c) “appointed date” means 1 October 2011;</p> <p>(d) “appropriate testing methodology” means a testing methodology which is:</p> <ul style="list-style-type: none"> i. representative of the range of services and customers for whom these performance targets are relevant; ii. capable of providing results with measurable statistical significance; and iii. compliant with Article 16 of the <u>Directive</u>; <p>with reference where relevant to harmonised standards adopted under Article 20 of the <u>Directive</u>.</p> <p>(e) “blind” means registered as blind under the provisions of the National Assistance Act 1948;</p> <p>(f) “Certificate of Posting” means a document issued or validated by a <u>post office</u> affirming that a <u>postal packet</u> has been deposited for conveyance;</p> <p>(g) “Christmas period” means the period commencing on the first Monday in December in any year and ending at the start of the first <u>working day</u> after the New Year <u>public holiday</u> in the following year or, in Scotland, at the start of the first <u>working day</u> after the Scottish New Year <u>public holiday</u> in the following year;</p> <p>(h) “Consumer Advocacy Bodies” means Citizens Advice, Citizens Advice Scotland and the General Consumer Council for Northern Ireland;</p> <p>(i) “deemed date of collection” has the meaning given in DUSP 1.2.1(b);</p> <p>(j) “deemed delivered”, in relation to a performance target applicable to</p>

a postal packet, means any of
(i) delivered or attempted to be delivered to the address given on the postal packet;
(ii) delivered to a person named as the addressee on the postal packet; or
(iii) delivered to an alternative delivery point approved by OFCOM.

- (k) “**deemed delivery date**” means the earlier of -
(i) the date upon which a postal packet is delivered to the address given on the postal packet;
(ii) the date upon which a postal packet is delivered to a person named as the addressee on the postal packet;
(iii) the date upon which a postal packet is delivered to an alternative delivery point requested by the addressee or approved by OFCOM;
(iv) the date upon which an unsuccessful attempt is made to deliver the postal packet in accordance with (i), (ii) or (iii) and the universal service provider offers the addressee a choice of redelivery within a reasonable period and an opportunity to collect the postal packet from any of the following places—
○ a post office;
○ a delivery office; or
○ another collection point approved by OFCOM for the purposes of this paragraph.
- (l) “**delivery office**” means an office managed by the universal service provider for the purposes of processing postal packets immediately prior to the activity of delivery to the addressee.
- (m) “**Directive**” means *Directive 97/67/EC of the European Parliament and of the Council on common rules for the development of the internal market of Community postal services and the improvement of quality of service, as amended by Directive 2002/39/EC of the European Parliament and of the Council of 10 June 2001, Regulation (EC) No 1882/2003 of the European Parliament and of the Council of 29 September 2003 and Directive 2008/6/EC of the European Parliament and of the Council of 20 February 2008*;
- (n) “**domestic**”, in relation to a postal service, means the service is for the conveyance of postal packets from access points in the United Kingdom to addresses in the United Kingdom.
- (o) “**EU office of exchange**” means a facility for—
(i) the collection by a universal service provider of postal packets originating from a country within the European Union other than the United Kingdom, for onward conveyance and delivery within the United Kingdom; or
(ii) the deposit by a universal service provider of postal packets originating from the United Kingdom, for onward conveyance and delivery to a country within the European Union other than the United Kingdom;
- (p) “**eligible items**” means
(i) books, papers and letters which are prepared for use by blind or partially sighted people,
(ii) papers sent to anyone to be prepared or impressed so blind or

- (iii) partially sighted people can use them,
- (iv) relief maps, machines, frames and attachments for making impressions for blind or partially sighted people to use,
- (v) writing frames and attachments for blind or partially sighted people to use,
- (vi) Braille instruction manuals,
- (vii) games (including card games) for blind or partially sighted people,
- (viii) mathematical appliances and attachments for blind or partially sighted people,
- (ix) recordings of readings from printed sources, such as books, journals, newspapers, periodicals or similar publications,
- (x) equipment used to play such recordings,
- (xi) metal plates impressed or sent for impressing for use by blind or partially sighted people,
- (xii) supplies of covers, envelopes and labels for sending articles for use by blind or partially sighted people,
- (xiii) watches, clocks, timers, tools and measuring equipment designed for blind or partially sighted people to use,
- (xiv) walking sticks adapted for blind or partially sighted people,
- (xv) harnesses for guide dogs; and
- (xvi) computer disks and CDs which are prepared for blind or partially sighted people;

(q) “**insured item**” means a postal packet the value of which has been declared to a universal service provider and of which, in the event of its theft or loss or damage in the course of its conveyance by post, the universal service provider has agreed to pay to the sender the declared value or such lesser sum as is consistent with the provision of the service at affordable prices;

(r) “**latest delivery time**” means, for each UK address, the time expressed in minutes past an hour by which the universal service provider endeavours to make a delivery every working day in accordance with the universal service provider’s classification, as at 1 December 2005, of addresses as either "urban" or "rural";

(s) “**letter box**” includes any pillar box, wall box, or other box or receptacle provided by a postal operator for the purpose of receiving postal packets, or any class of postal packets for onwards conveyance by post;

(t) “**meter**” means a method of evidencing payment for postal services provided by a universal service provider which involve the conveyance of a postal packet, through which the sender having paid in advance for postage applies an impression to a visible surface of the postal packet using a franking machine licensed by the universal service provider;

(u) “**partially sighted**” means certified by an ophthalmologist, doctor or ophthalmic optician as having vision which cannot be improved using optical aids (including magnifiers) or additional illumination to allow 12 point sized print to be read at a comfortable reading distance;

(v) “**post office**” means any premises or vehicle in the United Kingdom from which postal services are provided directly to the public;

- (w) “**postcode area**” means a geographical area indicated by the letters preceding the first number in the code, as the code is set out in the postcode address file;
- (x) “**postcode address file**” has the meaning given in s.116(3) Postal Services Act 2000;
- (y) “**postcode district**” means a geographical area indicated by the (alphabetical) letters and numbers in a postcode preceding the space in the code, as the code is set out in the postcode address file;
- (ya) “**priority and other letters**” means letters sent or delivered under any service in DUSP 1.6, except for standard letters; -
- (z) “**proof of delivery**” means a copy of a signature, or other evidence from the recipient in confirmation of receipt, obtained on delivery of a postal packet;
- (aa) “**public holiday**” means Christmas Day, Good Friday or a day which is a bank holiday under the Banking and Financial Dealings Act 1971 in any part of the United Kingdom, and, in relation to a particular territory or place, any day in relation to which OFCOM has by direction provided for an exception at that place under DUSP 1.3.2;
- (bb) “**registered item**” means a postal packet which has been registered with the universal service provider in connection with its conveyance by post and for which an amount determined by the universal service provider is payable to the sender in the event of theft or loss of or damage to it in the course of its conveyance by post;
- (cc) “**ROW office of exchange**” means a facility for—
- (i) the collection by a universal service provider of postal packets originating from a country outside the European Union, for onward conveyance and delivery within the United Kingdom; or
 - (ii) the deposit by a universal service provider of postal packets originating from the United Kingdom, for onward conveyance and delivery to a country outside the European Union.
- (dd) “**Royal Mail**” means Royal Mail Group Limited, whose registered company number in England and Wales is 04138203;
- (ee) “**single piece service**” means a postal service for a conveyance of an individual postal packet to the addressee, whose price per postal packet is not subject to any discounts related to—
- (i) the number of postal packets sent in connection with the person who paid for the service;
 - (ii) the positioning or formatting of text on the postal packet;
 - (iii) the use of markings which facilitate the use of machines to sort postal packets;
 - (iv) presortation into geographical areas for delivery; or
 - (v) the purchase of any other conveyance of the same or any other postal packet.
- (ff) “**specified collection time**” means, in relation to an access point used in the provision of a service set out in Condition DUSP 1.4, that period

1.3 Exceptions

DUSP 1.3.1	<p>Nothing in this DUSP Condition requires the doing of anything in relation to a <u>postal packet</u>—</p> <p>(a) whose weight exceeds 20 kilograms;</p> <p>(b) whose dimensions fall outside the minimum and maximum dimensions laid down in the Universal Postal Convention adopted by the 24th Congress of the Universal Postal Union, 2008⁷;</p> <p>(c) which contains an item which it is reasonable to exclude from carriage by post for reasons of potential harm to health, public security or compliance with law or other regulatory requirements; or</p> <p>(d) which does not comply with conditions reasonably imposed on an item's carriage by post for reasons of potential harm to health, public security or compliance with law or other regulatory requirements.</p>
DUSP 1.3.2	<p>The requirements in this DUSP Condition in respect of the delivery or collection of <u>postal packets</u> do not need to be met—</p> <p>(a) on any day which is (in the territory concerned) a <u>public holiday</u>; or</p> <p>(b) in such geographical conditions or other circumstances as <u>OFCOM</u> has by direction specified to be exceptional for the relevant purpose.</p>

DUSP 1.3.2A	<u>OFCOM</u> may by direction set out the things which must be done when exceptional circumstances under DUSP 1.3.2(b) may have arisen in any particular case, including but not limited to: reporting, notification, appeals, reviews and the establishment of alternative delivery or collection arrangements.
DUSP 1.3.3	The requirements in this DUSP Condition in respect of the delivery of <u>postal packets</u> , the <u>target routing times</u> of services and any associated quality of service performance targets do not need to be met in relation to a particular address or delivery point, where the addressee has acquired one or more <u>postal services</u> in accordance with which <u>postal packets</u> for that addressee are to be delayed or diverted.
DUSP 1.3.4	Nothing in this DUSP Condition is to be read— (a) as requiring a service to continue without interruption, suspension or restriction in an emergency; or (b) as preventing individual agreements as to prices from being concluded with customers.

1.4 Obligation to provide deliveries

DUSP 1.4.1	Except as set out in DUSP 1.3, the <u>universal service provider</u> shall offer to provide at least one delivery of priority and other letters originating from anywhere in the world every Monday to Saturday— (a) to the home or premises of every individual or other person in the UK; and (b) to delivery points approved by <u>OFCOM</u> for the purposes of this Condition.
DUSP 1.4.1A	Except as set out in DUSP 1.3, the <u>universal service provider</u> shall offer to provide delivery of <u>standard letters</u> on any day from Monday to Friday— (a) to the home or premises of every individual or other person in the UK; and (b) to delivery points approved by <u>OFCOM</u> for the purposes of this Condition.
DUSP 1.4.2	Except as set out in DUSP 1.3, the <u>universal service provider</u> shall offer to provide at least one delivery of other <u>postal packets</u> originating from anywhere in the world every Monday to Friday— (a) to the home or premises of every individual or other person in the UK; and (b) to delivery points approved by <u>OFCOM</u> for the purposes of this paragraph.

1.5. Obligation to provide collections

DUSP 1.5.1	Except as set out in DUSP 1.3, the <u>universal service provider</u> shall provide at least one collection— (a) every Monday to Saturday, from public <u>access points</u> for priority and other <u>letters</u> for the services described in DUSP 1.4; and (b) every Monday to Friday, from public <u>access points</u> for standard letters and other <u>postal packets</u> for the services described in DUSP 1.4.

1.6. Obligation to provide end-to-end services
