

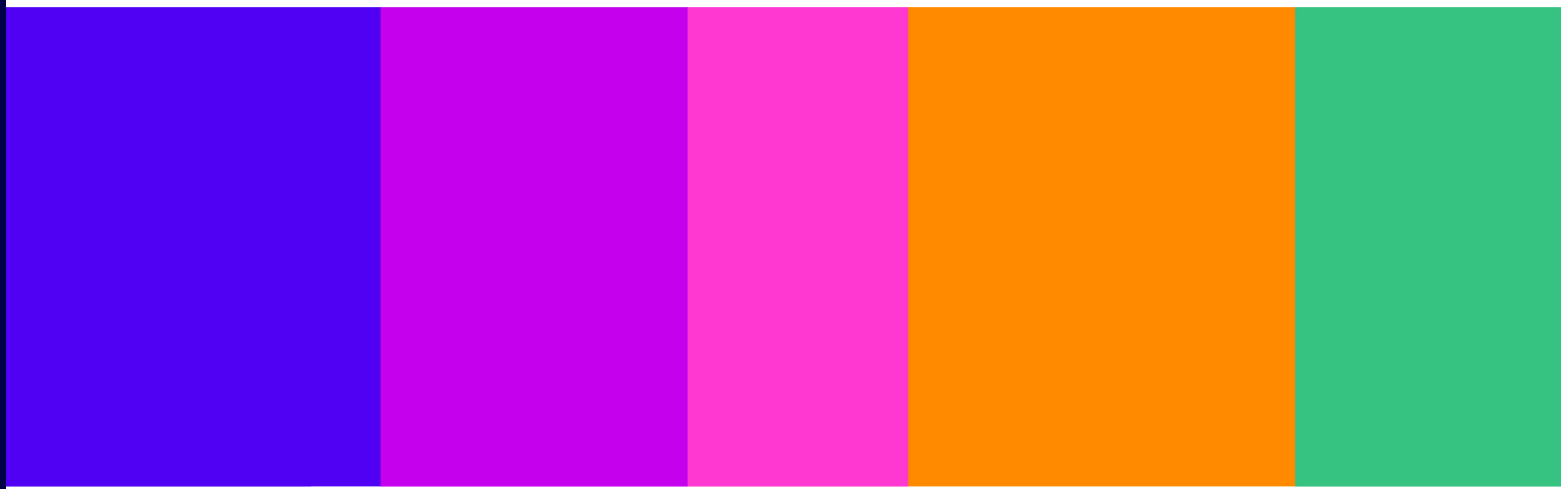
Proposal to apply Code powers to Clear Mobitel Ltd

Statutory notification under section 107(6) of the Communications Act 2003

1. Overview

- 1.1 The electronic communications code is a set of rights that are intended to assist providers of communications networks and/or systems of infrastructure. Operators to whom Ofcom applies the Code may:
- construct and maintain communications networks and infrastructure (such as ducts, cabinets and poles) on public highways without the need to obtain a street works licence to undertake such works;
 - construct communications infrastructure which is classified as ‘permitted developments’ under Town and Country Planning legislation (such as certain types of masts, poles and cabinets) without the need to apply for planning permission; and
 - in the event that agreement cannot be reached with the owner or occupier of private land, concerning the deployment of communications networks or infrastructure on private land to apply to the Court to impose an agreement which confers the Code right being sought by the operator or provides for the Code right to bind the landowner or occupier.
- 1.2 We consider applications for the grant of Code powers from providers of electronic communications networks and providers of systems of infrastructure (or both) with reference to the matters set out in section 107(4) of the Communications Act 2003.

What we are proposing – in brief

We are proposing to apply the electronic communications code set out in Schedule 3A to the Communications Act 2003 to Clear Mobitel Ltd, whose registered company number is 07067025, for the purposes of the provision by it of an electronic communications network and the provision of a system of infrastructure.

We invite comments on our proposal by 29 June 2026.

We will consider any responses to this consultation before reaching a final decision on whether to grant Code powers to Clear Mobitel Ltd.

2. Background

- 2.1 The electronic communications code (the Code) is set out in Schedule 3A to the Communications Act 2003 (the Act). It is designed to facilitate the installation and maintenance of electronic communications networks.¹ It confers rights on providers of such networks and on providers of systems of infrastructure to install and maintain apparatus on, under and over land and results in considerably simplified planning procedures.
- 2.2 Where the Code is applied in any person's case, it may be subject to restrictions and conditions set out in other legislation from time to time.²

The application of the Code

- 2.3 The Code only has effect in the case of a person to whom it is applied by a direction given by Ofcom (or, in the case of the Secretary of State or any Northern Ireland department, where the Secretary of State or that department is providing or proposing to provide an electronic communications network).³
- 2.4 The only purposes for which the Code may be applied in a person's case by a direction are:
- a) the purposes of the provision by him of an electronic communications network; or
 - b) the purposes of the provision by him of a system of infrastructure which he is making available, or proposing to make available, for use by providers of electronic communications networks for the purposes of the provision by them of their networks.⁴
- 2.5 A direction applying the Code to a person may take effect:
- a) in relation only to such places or localities as may be specified or described in the direction;
 - b) for the purposes only of the provision of such electronic communications network, or part of an electronic communications network, as may be so specified or described; or
 - c) for the purposes only of the provision of such system of infrastructure, or part of a system of infrastructure, as may be so specified or described.⁵

Application process for applying the Code

- 2.6 Ofcom must not give a direction applying the Code in any person's case except on an application made for the purpose by that person.⁶

- 2.7 Any such application must be made in accordance with the requirements for the time being in force with respect to the content of an application for a direction applying the Code and the manner in which such an application is to be made.⁷

Time limit for making a decision on applications for the Code

- 2.8 Regulation 3(2) of the Electronic Communications and Wireless Telegraphy Regulations 2011⁸ provides that, except in cases of expropriation, Ofcom must make its decision within 6 months of receiving the completed application. In other words, that time limit applies from the moment Ofcom receives an application that fully complies with the requirements described above.

Statutory consultation process on proposal

- 2.9 Before giving a direction applying the Code to the applicant in question, Ofcom must publish a notification of its proposal to give the direction and consider any representations about that proposal that are made to Ofcom within the period specified in the notification.⁹
- 2.10 Such a notification must contain the following¹⁰:
- a) a statement of Ofcom's proposal;¹¹
 - b) a statement of Ofcom's reasons for that proposal;
 - c) a statement of the period within which representations may be made to Ofcom about the proposal (which period must end no less than 30 days after the day of the publication of the notification¹²).
- 2.11 Ofcom must publish a notification in such manner as Ofcom considers appropriate for bringing the notification to the attention of the persons who, in Ofcom's opinion, are likely to be affected by it.¹³
- 2.12 The notification published at Annex 5 to this document is a notification for such purposes and should be read in conjunction with the entirety of this document, including the reasons set out in Section 3.

Relevant considerations in making a decision (four factors)

- 2.13 In considering whether to apply the Code in any person's case, Ofcom must have regard, in particular, to each of the following matters¹⁴:
- a) the benefit to the public of the electronic communications network or system of infrastructure by reference to which the Code is to be applied to that person;
 - b) the practicability of the provision of that network or system without the application of the Code;
 - c) the need to encourage the sharing of the use of electronic communications apparatus;
 - d) whether the person in whose case it is proposed to apply the Code will be able to meet liabilities arising as a consequence of the application of the Code in that person's case and any conduct of that person in relation to the matters with which the Code deals.
- 2.14 For the purposes of this process, those four factors rank equally with Ofcom's statutory duties under sections 3 and 4 of the Act.¹⁵ Where appropriate, outside of those statutory considerations, we will also have regard to any additional factors that, in our opinion, are relevant to the particular application.

Statutory duties

General duties

- 2.15 In carrying out its functions under the Act (which includes giving a direction to apply the Code), Ofcom's principal duty as set out in section 3 of the Act is to further the interests of citizens in relation to communications matters and to further the interests of consumers in relevant markets, where appropriate by promoting competition.
- 2.16 In so doing, we are required to secure a number of specific objectives and to have regard to a number of matters set out in section 3. As to the prescribed specific statutory objectives in section 3(2), we consider that the objective of securing the availability throughout the UK of a wide range of electronic communications services is particularly relevant to this consultation.
- 2.17 In performing its duties, Ofcom is also required to have regard to a range of other considerations, which appear to us to be relevant in the circumstances. In this context, we consider that a number of such considerations are relevant, particularly:
- a) the desirability of promoting competition in relevant markets;
 - b) the desirability of encouraging investment and innovation in relevant markets; and
 - c) the desirability of encouraging the availability and use of high-speed data transfer services throughout the United Kingdom.
- 2.18 We have also had regard to the principles under which regulatory activities should be transparent, accountable, proportionate, consistent, and targeted only at cases in which action is needed, as well as the interest of consumers in respect of choice, price, quality of service and value for money.

2.19 Ofcom has a wide measure of discretion in balancing its statutory duties and objectives. In so doing, we will take account of all relevant considerations, including any responses received during this consultation process, in reaching our conclusions.

Specific duties in relation to certain regulatory functions

2.20 When carrying out certain functions such as giving a direction to apply the Code, section 4 of the Act requires us to act in accordance with the six requirements set out in that section.

2.21 In summary, these six requirements are:

- a) to promote competition in the provision of electronic communications networks and services, associated facilities and the supply of directories;
- b) to promote the interests of all members of the public in the United Kingdom;
- c) to take account of the desirability of Ofcom's carrying out of its functions in a manner which, so far as practicable, does not favour one form of or means of providing electronic communications networks, services or associated facilities over another, i.e. to be technologically neutral;
- d) to encourage, to such extent as Ofcom considers appropriate for certain prescribed purposes, the provision of network access and service interoperability, namely securing efficiency and sustainable competition, efficient investment and innovation and the maximum benefit for customers of communications providers and of persons who make associated facilities available;
- e) to encourage compliance with certain standards as is necessary to facilitate service interoperability; facilitate end-to-end connectivity; facilitate the changing by end-users of their communications provider; facilitate the retention by end-users of their telephone numbers after a change of communications provider; and secure freedom of choice for the customers of communications providers.
- f) to promote connectivity and access to very high-capacity networks by members of the public and businesses in the United Kingdom.

2.22 We consider that the first, second, fourth and sixth of those requirements are of particular relevance to our proposal in this consultation and that no conflict arises in this regard with the specific objectives in section 3 which we have identified above as particularly relevant in this context.

Matters outside the scope of this consultation

2.23 Ofcom's role in relation to the granting of Code powers is limited to considering applications by individual providers of electronic communications networks and/or systems of infrastructure, taking account of its statutory duties under sections 3, 4 and 107(4) of the Communications Act 2003 as set out above.

2.24 Ofcom is therefore unable to consider comments about Government policy underpinning the statutory framework that sets out the Code, and the rights available to Code operators to facilitate the rollout of advanced communications networks.

2.25 Ofcom is also unable to consider comments concerning Government policy and the safety of electromagnetic fields (EMFs). Providers do not require Code powers to deploy equipment which emit EMFs, nor does the Code set safety levels for such emissions. We have published an advice page on our website, which explains the regulation of EMFs and identifies the

organisations responsible for ensuring that mobile operators comply with the relevant regulations.¹⁶

Impact assessment

- 2.26 Section 7 of the Communications Act 2003 requires us to carry out and publish an assessment of the likely impact implementing a proposal would have on businesses or the general public, if the impact is likely to be significant, or when a change in Ofcom’s activities is major.
- 2.27 More generally, impact assessments form part of good policy making and we therefore expect to carry them out in relation to a large majority of our proposals. We use impact assessments to help us understand and assess the potential impact of our policy decisions before we make them. They also help us explain the policy decisions we have decided to take and why we consider those decisions best fulfil our applicable duties and objectives in the least intrusive way. Our impact assessment guidance sets out our general approach to how we assess and present the impact of our proposed decisions.¹⁷
- 2.28 The relevant duties in relation to the proposal on which we are consulting are set out above. As discussed in paragraph 2.13, these include the four factors which we are required to have particular regard to when considering whether to apply the Code in a person’s case. We consider these are particularly relevant to our assessment of the impact of this proposal.
- 2.29 We expect this proposal to have an overall positive impact for citizens and consumers because the grant of Code powers will facilitate the deployment of an electronic communications network and system of infrastructure by the applicant as described in section 3.
- 2.30 We expect the deployment of such networks and infrastructure systems to improve the quality of services available and help meet the growing needs of people and businesses for connectivity. Where providers expand their network coverage, we expect competition to fuel innovation and customer choice.
- 2.31 In section 3, we have also summarised the benefits which the applicant considers would be associated with the proposed network and infrastructure deployment.
- 2.32 For completeness, we note that street works associated with the proposed network and infrastructure system deployment may cause short term disruption to citizens. This could include street closures, traffic restrictions and noise associated with works to install electronic communications apparatus. There may also be a visual impact if the applicant deploys apparatus such as cabinets, poles and overhead lines. We note that operators to whom the Code is applied have rights to deploy electronic communications apparatus in public highways, subject to certain obligations as set out in conditions and restrictions attached to the Code, street works legislation and planning legislation. These obligations include requirements relating to the conduct of street works, the types of apparatus that may be installed, the visual impact of apparatus and the applicable planning requirements.
- 2.33 In considering the potential impact of the proposal on which we are consulting, we have considered the following options:

- a) give a direction to apply the Code to the Applicant; or
- b) not to give such a direction.

Equality impact assessment

- 2.34 We have given careful consideration to whether our proposal will have a particular impact on persons sharing protected characteristics (broadly including race, age, disability, sex, sexual orientation, gender reassignment, pregnancy and maternity, marriage and civil partnership and religion or belief in the UK and also dependents and political opinion in Northern Ireland), and in particular whether they may discriminate against such persons or impact on equality of opportunity or good relations. This assessment helps us comply with our duties under the Equality Act 2010 and the Northern Ireland Act 1998.¹⁸
- 2.35 When thinking about equality we think more broadly than persons that share protected characteristics identified in equalities legislation and think about potential impacts on various groups of persons (see paragraph 4.7 of our [impact assessment guidance](#)).
- 2.36 In particular, section 3(4) of the Communications Act also requires us to have regard to the needs and interests of specific groups of persons when performing our duties, as appear to us to be relevant in the circumstances. These include:
- the vulnerability of children and of others whose circumstances appear to us to put them in need of special protection;
 - the needs of persons with disabilities, older persons and persons on low incomes; and
 - the different interests of persons in the different parts of the UK, of the different ethnic communities within the UK and of persons living in rural and in urban areas.
- 2.37 We consider that our proposals may have a positive impact on specific groups of persons (including persons that share protected characteristics under the 2010 Act or the 1998 Act) differently to the general population. As noted in our impact assessment above, our proposal will facilitate the deployment of an electronic communications network and system of infrastructure by the applicant which we expect to have an overall positive impact on citizens. Specific groups may benefit more than the general population, depending on the locations that the applicant chooses to deploy its network. For example, the applicant may deploy its network in locations where those with protected characteristics are particularly represented or in urban or rural areas, which may help advance equality of opportunity in those areas.
- 2.38 In section 3, we have described the differential effects that we have identified. However, given the narrow scope of our proposal and that the locations where the applicant ultimately deploys its network and system of infrastructure are at its discretion, we have not sought to undertake a detailed assessment of these positive differential impacts.

3. Reasons for proposal

3.1 This section contains our reasons for proposing to apply the Code to Clear Mobitel Ltd.

Factual matters

The Applicant and the Code powers applied for

3.2 On 21 March 2026 we received an application that meets the statutory requirements.¹⁹

3.3 The person seeking Code powers (the Applicant) is:

- Company name: Clear Mobitel Ltd
- Registered company number: 07067025
- Registered office: Msparc, Parc Gwyddoniaeth Menai, Gaerwen, Wales, LL60 6AG

3.4 The Applicant has applied to Ofcom for a direction applying Code powers under section 106(4)(a) and (b) of the Act. Namely, for the purposes of the provision by the Applicant of an electronic communications network; and for the purposes of the provision by the Applicant of a system of infrastructure which it is making available, or proposing to make available for use by providers of electronic communications networks for the purposes of the provision by them of their networks.

Description and location of the network or system of infrastructure for Code powers

3.5 The Applicant intends to provide an electronic communications network comprising 5G New Radio (NR) radio access infrastructure, fibre and microwave backhaul, and a cloud-native 5G Standalone core network. The Applicant has noted that its proposed network would deliver 5G Fixed Wireless Access (FWA) broadband services to residential and business premises, wholesale connectivity to Internet Service Providers (ISPs), and enterprise 5G solutions.

3.6 The Applicant also intends to provide a system of infrastructure which it proposes to make available for use by other providers of electronic communications networks. This system comprises mast and pole structures, duct infrastructure, dark fibre connectivity, and cabinet/equipment housing — all of which would be offered to other operators on an open-access, wholesale basis. The Applicant has noted its proposed open-access wholesale infrastructure model is a core element of its business plan.

3.7 The Applicant plans to initially focus deployment of its proposed electronic communications network and system of infrastructure in Wales and to explore cross-border connectivity opportunities across the UK at a later stage.

Analysis of the four factors

3.8 As set out in paragraph 2.13 above, Ofcom must have regard to four factors when considering whether to apply the Code in any person's case.

The benefit to the public of the electronic communications network and system of infrastructure by reference to which the Code is to be applied to the Applicant

3.9 The Applicant considers that its proposed electronic communications network and system of infrastructure would benefit the public as:

- It intends to deliver high-speed broadband to 5,000 premises in Year 1, rising to 25,000 by Year 5, in underserved areas in Wales and across the UK with limited or no connectivity.
- It intends to introduce into the market an additional wholesale infrastructure provider on an open-access basis, increasing choice for consumers and businesses. The Applicant intends to maximise the public benefit of the system of infrastructure by enabling multiple service providers to reach underserved communities, without duplicating physical network build.
- It intends to support economic development through Small and Medium-sized Enterprises (SME) growth, agricultural innovation, tourism and public service delivery in rural areas of Wales.
- It intends to, as the network and infrastructure is deployed, generate jobs at its Anglesey-based headquarters.
- It intends to help ensure network security by building a modern, secure 5G network using only approved non-high-risk vendors.
- It intends to achieve deployment of faster network coverage at a lower public costs, through cost-effective network and infrastructure deployment.

3.10 We expect the deployment of a new electronic communications network and system of infrastructure to improve the quality of services available and help meet the growing needs of people and businesses for connectivity. Where providers expand their network coverage, we expect competition to fuel innovation and customer choice.

3.11 For completeness, we note that any potential future street works associated with the deployment of the proposed electronic communications network and system of infrastructure may cause short term disruption to citizens. This could include street closures, traffic restrictions and noise associated with works to install electronic communications apparatus. There may also be a visual impact if the Applicant deploys apparatus such as cabinets, poles and overhead lines. We note that operators to whom the Code is applied have rights to deploy electronic communications apparatus in public highways, subject to certain obligations as set out in conditions and restrictions attached to the Code, street works legislation and planning legislation. These obligations include requirements relating to the conduct of street works, the types of apparatus that may be installed, the visual impact of apparatus and the applicable planning requirements. We consider that the proposed network deployment and infrastructure system planned by the Applicant would have the potential to benefit the public.

The practicability of the provision of the network and infrastructure system without the application of the Code

3.12 The Applicant has stated it would be unable to commercially deploy and maintain its proposed network and system of infrastructure without Code powers because:

- The Applicant considers without Code powers, it cannot negotiate effectively with landowners, access wholesale infrastructure, or satisfy investor due diligence. Code powers would give it greater bargaining power with landowners and would enable it to apply to the court to impose an agreement in the event that it is unable to secure satisfactory terms for access to private land to deploy its apparatus.
- Code powers will allow the Applicant to deploy fibre along public highways to connect base stations, as without Code powers, it would not have the right to deploy apparatus in streets and would therefore need to apply for street works licences, pursuant to section 50 of the New Roads and Street Works Act 1991. Given that such licenses are a discretionary grant, the Applicant considers that this would not provide the certainty, scope or permanence required for its proposed network deployment.
- The Applicant considers the permitted development simplified planning procedures which are available to Code operators as essential for deploying 5G infrastructure at volume. It notes that, in the absence of Code powers it would not benefit from the permitted development simplified planning procedures and would, therefore, need to apply for planning permission to deploy certain types of infrastructure. The Applicant considers that this would add significant cost, delay and uncertainty to the deployment programme.
- The Applicant states that the 5G FWA network relies on line-of-sight or near-line-of-sight transmission. The Applicant therefore considers that the Code right to manage vegetation interfering with apparatus would be essential in the heavily wooded North Wales landscape.

3.13 We consider that providing the network planned by the Applicant would not be practicable without the application of the Code.

The need to encourage the sharing of the use of electronic communications apparatus

3.14 The applicant has confirmed that it is seeking to share the use of its electronic communications apparatus with other operators. Specifically, the Applicant intends to:

- Make mast and pole infrastructure available for co-location by other electronic communications operators, where technically feasible and subject to reasonable commercial terms and structural capacity.
- Make use of Openreach's Physical Infrastructure Access (PIA) service.
- Offer wholesale open-access services over its 5G FWA network, enabling other communications providers to deliver broadband services to end users without deploying their own radio infrastructure.
- Consider requests for access to duct, dark fibre and other passive infrastructure deployed as part of the network build, on fair and reasonable terms.
- Engage constructively with any Code operator seeking to share apparatus.

Whether the Applicant will be able to meet liabilities as a consequence of (i) the application of the Code; and (ii) any conduct in relation to the application of the Code

- 3.15 The Applicant has provided us with information, along with its application, that confirms that it understands its obligations to provide funds for liabilities under Regulation 16²⁰, and confirmation by a director of the company that it will ensure that sufficient funds for these liabilities are in place (and will provide Ofcom with a certificate to this effect) if, and when this becomes necessary.
- 3.16 We consider that, based on this information, the Applicant would be able to meet its liabilities.

Overall assessment

- 3.17 In addition to our consideration of the four factors discussed above in paragraph 2.13, we consider that our proposal would secure or further the performance of our statutory duties under sections 3 and 4 of the Act.
- 3.18 In particular, we consider that our proposal would encourage investment and innovation by facilitating the provision of an electronic communications network and system of infrastructure by the Applicant. The provision of such a network and infrastructure system would promote access to very high-capacity networks and encourage the availability of a wide range of communications services, including high-speed data transfer services. In our view this would also help support the future development, growth and availability of modern communications services in the public interest.
- 3.19 We consider this proposal will improve the quality of services available and help meeting the growing connectivity needs of people and businesses.
- 3.20 We consider that the Applicant's system of infrastructure could enhance competition in the provision of such infrastructure as the applicant offers wholesale infrastructure services in competition with other providers of such services.
- 3.21 We also consider that the Applicant's intended network could also enhance competition and customer choice as the Applicant proposes to offer retail services in competition with existing telecoms providers and to provide wholesale services to other telecoms providers.
- 3.22 The effect of implementing the proposal is likely to be low. Any costs to those affected by the Applicant's use of Code powers are likely to be outweighed by the benefits. On the other hand, the detrimental effect on the Applicant of a refusal to grant such powers (including to the practicability of its network roll-out) is likely to be significant.
- 3.23 We are also of the view that the effect of our proposal is not likely to be to the detriment of any protected group within society.

Proposal

- 3.24 Having considered the Applicant's application for Code powers, we propose that the Code should have effect in its case for the provision by the Applicant of an electronic communications network, and for the provision of a system of infrastructure which the Applicant is making available, or proposing to make available, for use by providers of electronic communications for the purposes of the provision by them of their networks in the United Kingdom.
- 3.25 We consider that our proposal is appropriate having regard to the considerations set out in section 107(4) of the Act. We consider that the performance of our statutory duties in sections 3 and 4 of the Act would be secured and furthered in relation to this proposal.
- 3.26 We will consider any responses we may receive by the closing date before making our decision as to whether we should give a direction applying the Code to the Applicant.

The overview section in this document is a simplified high-level summary only. The proposals we are consulting on and our reasoning are set out in the full document.

Before the consultation

A2.1 Wherever possible, we will hold informal talks with people and organisations before announcing a big consultation, to find out whether we are thinking along the right lines. If we do not have enough time to do this, we will hold an open meeting to explain our proposals, shortly after announcing the consultation.

During the consultation

A2.2 We will be clear about whom we are consulting, why, on what questions and for how long.

A2.3 We will make the consultation document as short and simple as possible, with an overview of no more than two pages. We will try to make it as easy as possible for people to give us a written response.

A2.4 We will consult for up to ten weeks, depending on the potential impact of our proposals.

A2.5 A person within Ofcom will be in charge of making sure we follow our own guidelines and aim to reach the largest possible number of people and organisations who may be interested in the outcome of our decisions. [Proposed] Direction under section 106(3) of the Communications Act 2003 applying the electronic communications code

Background

1. Clear Mobitel Ltd, whose registered company number is 07067025 has applied to Ofcom for a direction applying the Code to it.
2. The date on which Ofcom received a completed application that meets the statutory requirements with respect to the content of an application for a direction applying the Code and the manner in which such an application is to be made was 21 March 2026.
3. By virtue of regulation 3 of the Electronic Communications and Wireless Telegraphy Regulations 2011 (SI 2011 No. 1210), except in cases of expropriation, Ofcom must make its decision within 6 months of receiving the completed application.
4. Prior to giving a decision under section 106(3) of the Act to apply the Code to Clear Mobitel Ltd, Ofcom must publish a notification of its proposal to give the direction and consider any representations about that proposal that are made to Ofcom within the period specified in the notification.
5. On 28 May 2026, Ofcom published a notification in accordance with section 107(6) of the Act of its proposal to give a direction applying the Code to Clear Mobitel Ltd. That notification invited representations to Ofcom by no later than 5pm on 29 June 2026.
6. *[Ofcom has considered every representation about the proposal made to it/Ofcom did not receive any representations about the proposal]*. For the reasons set out in the explanatory statement accompanying Ofcom's consultation, Ofcom has had regard, in particular, to each of the matters set out in section 107(4) of the Act. Furthermore, Ofcom has considered and acted in accordance with its general duties in section 3 of the Act and the six requirements in section 4 of the Act.

Decision

7. Ofcom hereby directs, in accordance with section 106 of the Act, as follows—
 - (a) the Code shall apply to Clear Mobitel Ltd (whose registered company number is 07067025) for the purposes of the provision by it of:
 - i. an electronic communications network; and
 - ii. a system of infrastructure which it is making available, or proposing to make available, for use by providers of electronic communications networks for the purposes of the provision by them of their networks; and
 - (b) that application of the Code shall have effect throughout the United Kingdom.
8. This Direction shall take effect on the day it is published.

Interpretation

9. In this Direction—
 - (a) “**Act**” means the Communications Act 2003;
 - (b) “**Code**” means the electronic communications code set out in Schedule 3A to the Communications Act 2003;
 - (c) “**Ofcom**” means the Office of Communications.

10. For the purpose of interpreting this Direction—

- (a) headings and titles shall be disregarded;
- (b) the Interpretation Act 1978 shall apply as if this Notification were an Act of Parliament.
