

# Proposal to modify the terms on which the Code is applied to Jurassic Fibre Limited

Statutory notification under section 107(6) of the Communications Act 2003

#### 1. Overview

The electronic communications code (the Code) is a set of rights that are intended to assist providers of electronic communications networks and/or systems of infrastructure. Operators to whom Ofcom applies the Code may:

- construct and maintain communications networks and infrastructure (such as ducts, cabinets and poles) on public highways without the need to obtain a street works licence to undertake such works;
- construct communications infrastructure which is classified as 'permitted developments' under Town and Country Planning legislation (such as certain types of masts, poles and cabinets) without the need to apply for planning permission; and
- in the event that agreement cannot be reached with the owner or occupier of private land, concerning the deployment of communications networks or infrastructure on private land to apply to the Court to impose an agreement which confers the Code right being sought by the operator or provides for the Code right to bind the landowner or occupier.

We consider operators' applications for the grant of Code powers, and modifications to such Code powers, with reference to the matters set out in sections 107(4) and section 115(4A) of the Communications Act 2003, respectively.

#### What we are proposing - in brief

Ofcom previously gave a direction applying the electronic communications code set out in Schedule 3A to the Communications Act 2003 to Jurassic Fibre Limited, whose registered company number is 11427267, for the purposes of the provision by it of an electronic communications network in England. Ofcom has received a further application from Jurassic Fibre Limited to modify the terms on which the Code is applied to Jurassic Fibre Limited so that its Code powers are extended beyond England to the rest of the UK. Having considered the application, we are proposing to modify the terms on which the electronic communications code applies to Jurassic Fibre Limited to extend its application to the whole of the UK.

We invite comments on our proposal by 12 July 2021.

We will consider any responses to this consultation before reaching a final decision on whether to confirm our proposal.

### 2. Background

- 2.1 The electronic communications code (the Code) is set out in Schedule 3A to the Communications Act 2003 (the Act). It is designed to facilitate the installation and maintenance of electronic communications networks. It confers rights on providers of such networks and on providers of systems of infrastructure to install and maintain apparatus on, under and over land and results in considerably simplified planning procedures.
- 2.2 Where the Code is applied in any person's case, it may be subject to restrictions and conditions set out in other legislation from time to time.<sup>2</sup>

#### The application of the Code

- 2.3 The Code only has effect in the case of a person to whom it is applied by a direction given by Ofcom (or, in the case of the Secretary of State or any Northern Ireland department, where the Secretary of State or that department is providing or proposing to provide an electronic communications network).<sup>3</sup>
- 2.4 The only purposes for which the Code may be applied in a person's case by a direction are:
  - a) the purposes of the provision of an electronic communications network; or
  - b) the purposes of the provision of a system of infrastructure which he is making available, or proposing to make available, for use by providers of electronic communications networks for the purposes of the provision by them of their networks.<sup>4</sup>
- 2.5 By virtue of section 106(5) of the Act, a direction applying the Code to a person may take effect:
  - a) in relation only to such places or localities as may be specified or described;
  - b) for the purposes only of the provision of such electronic communications network, or part of an electronic communications network, as may be so specified or described; or
  - c) for the purposes only of the provision of such system of infrastructure, or part of a system of infrastructure, as may be so specified or described.
- 2.6 Of com may at any time modify the terms on which, by virtue of section 106(5), the Code is applied in a person's case. Such a modification shall be by a further direction under

section 106 to the person in whose case the electronic communications code has been applied by the direction being modified.<sup>6</sup>

#### **Application process for applying the Code**

- 2.7 Ofcom must not give a direction applying the Code in any person's case except on an application made for the purpose by that person.<sup>7</sup>
- 2.8 Any such application must be made in accordance with the requirements for the time being in force with respect to the content of an application for a direction applying the Code and the manner in which such an application is to be made.<sup>8</sup>

#### Time limit for making a decision on applications for the Code

2.9 Regulation 3(2) of the Electronic Communications and Wireless Telegraphy Regulations 2011° provides that, except in cases of expropriation, Ofcom must make its decision within 6 months of receiving the completed application. In other words, that time limit applies from the moment Ofcom receives an application that fully complies with the requirements described above.

#### Statutory consultation process on proposal

- 2.10 Before giving a direction applying the Code to an applicant, or modifying the terms on which the Code is applied to a person, Ofcom must publish a notification of its proposal to give the direction and consider any representations about that proposal that are made to Ofcom within the period specified in the notification.<sup>10</sup>
- 2.11 Such a notification must contain the following<sup>11</sup>:
  - a) a statement of Ofcom's proposal;12
  - b) a statement of Ofcom's reasons for that proposal;
  - c) a statement of the period within which representations may be made to Ofcom about the proposal (which period must end no less than 30 days after the day of the publication of the notification<sup>13</sup>).

- 2.12 Ofcom must publish a notification in such manner as Ofcom considers appropriate for bringing the notification to the attention of the persons who, in Ofcom's opinion, are likely to be affected by it.<sup>14</sup>
- 2.13 The notification published at Annex 5 to this document is a notification for such purposes and should be read in conjunction with the entirety of this document, including the reasons set out in Section 3.

#### Relevant considerations in making a decision

- 2.14 In considering whether to apply the Code in any person's case, Ofcom must have regard, in particular, to each of the following four factors<sup>15</sup>:
  - a) the benefit to the public of the electronic communications network or system of infrastructure by reference to which the Code is to be applied to that person;
  - b) the practicability of the provision of that network or system without the application of the Code;
  - c) the need to encourage the sharing of the use of electronic communications apparatus;
  - d) whether the person in whose case it is proposed to apply the Code will be able to meet liabilities arising as a consequence of the application of the Code in that person's case and any conduct of that person in relation to the matters with which the Code deals.
- 2.15 For the purposes of this process, the above four factors rank equally with Ofcom's statutory duties under sections 3 and 4 of the Act. 16
- 2.16 In considering whether to modify the terms on which the Code is applied in a person's case, the modification may not be made unless it is:
  - a) objectively justifiable; and
  - b) proportionate to what it is intended to achieve. 17
- 2.17 Where appropriate, outside of those statutory considerations, we will also have regard to any additional factors that, in our opinion, are relevant to the particular case.

#### **Statutory duties**

#### **General duties**

2.18 In carrying out its functions under the Act (which includes giving a direction to apply the Code or to modify the terms on which the Code is applied to a person), Ofcom's principal duty as set out in section 3 of the Act is to further the interests of citizens in relation to

- communications matters and to further the interests of consumers in relevant markets, where appropriate by promoting competition.
- 2.19 In so doing, we are required to secure a number of specific objectives and to have regard to a number of matters set out in section 3. As to the prescribed specific statutory objectives in section 3(2), we consider that the objective of securing the availability throughout the UK of a wide range of electronic communications services is particularly relevant to this consultation.
- 2.20 In performing its duties, Ofcom is also required to have regard to a range of other considerations, which appear to us to be relevant in the circumstances. In this context, we consider that a number of such considerations are relevant, particularly:
  - a) the desirability of promoting competition in relevant markets;
  - b) the desirability of encouraging investment and innovation in relevant markets; and
  - c) the desirability of encouraging the availability and use of high-speed data transfer services throughout the United Kingdom.
- 2.21 We have also had regard to the principles under which regulatory activities should be transparent, accountable, proportionate, consistent, and targeted only at cases in which action is needed, as well as the interest of consumers in respect of choice, price, quality of service and value for money.
- 2.22 Ofcom has a wide measure of discretion in balancing its statutory duties and objectives. In so doing, we will take account of all relevant considerations, including any responses received during this consultation process, in reaching our conclusions.

#### Specific duties in relation to certain regulatory functions

- 2.23 When carrying out certain functions such as giving a direction to apply the Code or to modify the terms on which the Code is applied to a person, section 4 of the Act requires us to act in accordance with the six requirements set out in that section.
- 2.24 In summary, these six requirements are:
  - a) to promote competition in the provision of electronic communications networks and services, associated facilities and the supply of directories;
  - b) to promote the interests of all members of the public in the United Kingdom;
  - to take account of the desirability of Ofcom's carrying out of its functions in a manner which, so far as practicable, does not favour one form of or means of providing electronic communications networks, services or associated facilities over another, i.e. to be technologically neutral;
  - d) to encourage, to such extent as Ofcom considers appropriate for certain prescribed purposes, the provision of network access and service interoperability, namely securing efficiency and sustainable competition, efficient investment and innovation and the

- maximum benefit for customers of communications providers and of persons who make associated facilities available;
- e) to encourage compliance with certain standards as is necessary to facilitate service interoperability; facilitate end-to-end connectivity; facilitate the changing by end-users of their communications provider; facilitate the retention by end-users of their telephone numbers after a change of communications provider; and secure freedom of choice for the customers of communications providers.
- f) to promote connectivity and access to very high capacity networks by members of the public and businesses in the United Kingdom.
- 2.25 We consider that the first, second, fourth and sixth of those requirements are of particular relevance to our proposal in this consultation and that no conflict arises in this regard with the specific objectives in section 3 which we have identified above as particularly relevant in this context.

#### **Impact** assessment

- 2.26 The analysis presented in the entirety of this consultation represents an impact assessment, as defined in section 7 of the Act.
- Impact assessments provide a valuable way of assessing different options for regulation and showing why the preferred option was chosen. They form part of best practice policy-making. This is reflected in section 7 of the Act, which means that generally Ofcom has to carry out impact assessments where its proposals would be likely to have a significant effect on businesses or the general public, or when there is a major change in Ofcom's activities. However, as a matter of policy Ofcom is committed to carrying out and publishing impact assessments in relation to the vast majority of its policy decisions. - 2.28 Specifically, pursuant to section 7, an impact assessment must set out how, in our opinion, the performance of our general duties (within the meaning of section 3 of the Act) is secured or furthered by or in relation to what we propose.
- 2.29 There are two main options for this consultation:
  - a) give a direction to apply the Code to the Applicant; or
  - b) not to give such a direction.

#### **Equality impact assessment**

2.30 Section 149 of the Equality Act 2010 (the 2010 Act) imposes a duty on Ofcom, when carrying out its functions (which includes giving a direction to apply the Code), to have due regard to the need to eliminate discrimination, harassment, victimisation and other

- prohibited conduct related to the following protected characteristics: age; disability; gender reassignment; marriage and civil partnership; pregnancy and maternity; race; religion or belief; sex and sexual orientation. The 2010 Act also requires Ofcom to have due regard to the need to advance equality of opportunity and foster good relations between persons who share specified protected characteristics and persons who do not.
- 2.31 Section 75 of the Northern Ireland Act 1998 (the 1998 Act) also imposes a duty on Ofcom, when carrying out its functions relating to Northern Ireland, to have due regard to the need to promote equality of opportunity and regard to the desirability of promoting good relations across a range of categories outlined in the 1998 Act. Ofcom's Revised Northern Ireland Equality Scheme explains how we comply with our statutory duties under the 1998 Act.
- 2.32 To help us comply with our duties under the 2010 Act and the 1998 Act, we assess the impact of our proposals on persons sharing protected characteristics and in particular whether they may discriminate against such persons or impact on equality of opportunity or good relations.
- 2.33 We do not consider that our proposals have equality implications under the 2010 Act or the 1998 Act.

### 3. Reasons for proposal

3.1 This section contains our reasons for proposing to modify the terms on which the Code is applied to Jurassic Fibre Limited.

#### **Factual matters**

#### The Applicant and the modification of Code powers applied for

- 3.2 On 12 May 2021 we received an application to modify the terms on which the Code is applied to Jurassic Fibre Limited.
- 3.3 The person seeking a modification to its Code powers (the Applicant) is:
  - Company name: Jurassic Fibre Limited
  - Registered company number: 11427267
  - Registered office: 6<sup>th</sup> Floor, 33 Holborn, London, EC1N 2HT
- 3.4 The Code currently applies to the Applicant pursuant to a direction under section 106(3) of the Act, given by Ofcom on 22 October 2019. The Code applies to the Applicant for the purposes of the provision by it of an electronic communications network throughout England only. 18 The Applicant is seeking a further direction under section 106 of the Act to modify the terms on which, by virtue of section 106(5) of the Act, the Code applies to it so that its Code powers are extended beyond England to the rest of the UK.

# Description and location of the network or system of infrastructure for Code powers

- 3.5 The Applicant is a Code operator currently operating a fibre to the premises (FTTP) access network in Devon and Somerset. The Applicant provides ultrafast broadband services to homes, businesses and local authorities.
- 3.6 The Applicant plans to extend its FTTP access network to selected locations throughout the UK, in particular in locations outside England. In connection with these plans, the Applicant has applied to Ofcom for a further direction to modify the geographic scope of its Code powers so that it may use Code powers to deploy an electronic communications network in other parts of the UK.

#### **Analysis of the four factors**

3.7 As set out in paragraph 2.14 above, Ofcom must have regard to four factors when considering whether to apply the Code in any person's case.

# The benefit to the public of the electronic communications network by reference to which the Code is to be applied to the Applicant

- 3.8 The Applicant has stated that the proposed extension of its FTTP network in other parts of the UK would be in selected towns and villages where ultrafast broadband services are not currently available, namely areas currently served mainly by BT's copper access network. It considers that its ultrafast broadband services would bring significant benefits, including by making the areas served by its network more attractive locations for high-tech businesses and facilitating the rollout of digital care services increasingly promoted by local authorities.
- 3.9 We expect the deployment of new full fibre networks to improve the quality of services available and help meet the growing needs of people and businesses for connectivity. Where providers expand their network coverage, we expect competition to fuel innovation and customer choice.
- 3.10 We consider that the network extension planned by the Applicant would have the potential to benefit the public.

# The practicability of the provision of the network without the application of the Code

- 3.11 The Applicant has stated that without Code powers, the proposed network extension would be hampered by a number of factors, including:
  - Relying on the full Town and Country Planning Act process would neither be practicable
    from a business point of view nor feasible financially, and the costs and delays
    associated with the process would be prohibitive. Additionally, the Applicant has stated
    that initiating the process each time it needs to install a structure would prevent it
    from being able to respond promptly to customers' demand for new facilities.
  - Securing access to public and private land to deploy its network would be time consuming and cost-ineffective
- 3.12 The Applicant has also stated that without Code powers it would be at a commercial disadvantage to other telecoms operators.
- 3.13 We consider that the business case for a broadband network is generally dependent upon the level of costs of building the network and the timely provision and take-up of services. Without the application of the Code, the Applicant's costs would likely be higher, and the time taken to then provide services, longer. We consider that, together, these effects could impair the Applicant's business case for expanding its network.
- 3.14 We consider that the network extension planned by the Applicant would not be practicable without the application of the Code.

# The need to encourage the sharing of the use of electronic communications apparatus

- 3.15 The Applicant has stated that it is willing to provide wholesale services to other operators, subject to the agreement of mutually acceptable commercial terms.
- 3.16 Network sharing will help to minimise the unnecessary proliferation of electronic communications apparatus, bringing environmental benefits aligned with long standing Government objectives in the public interest.
- 3.17 We consider that sharing of the use of apparatus would be encouraged by the proposed modification of the Applicant's Code powers.

# Whether the Applicant will be able to meet liabilities as a consequence of (i) the application of the Code; and (ii) any conduct in relation to the application of the Code

- 3.18 The Applicant has provided us with information, along with its application, that confirms that it understands its obligations to provide funds for liabilities under Regulation 16<sup>19</sup>, and confirmation by a director of the company that it will ensure that sufficient funds for these liabilities are in place (and will provide Ofcom with a certificate to this effect) if, and when this becomes necessary.
- 3.19 We consider that, based on this information, the Applicant would be able to meet its liabilities.

# Whether the proposal to modify the terms is objectively justifiable and proportionate to what it is intended to achieve.

- 1.1 We consider that our proposal to modify the terms on which the Code is applied in the Applicant's case is:
  - objectively justifiable because our proposal is consistent with the four factors which
    Ofcom must have regard to, and it would facilitate the Applicant's plans to expand its
    network to the rest of the UK.
  - proportionate in what it is intended to achieve because the proposed modification to the terms on which the Code is applied in the Applicant's case is the minimum necessary to facilitate the Applicant's plans.

#### **Overall assessment**

3.20 In addition to our consideration of the factors discussed above in paragraphs 3.7 to 3.20, we consider that our proposal would secure or further the performance of our statutory duties under sections 3 and 4 of the Act.

- 3.21 In particular, we consider that our proposal to modify the terms on which the Code applies to extend the geographic scope of the Applicant's Code powers to the rest of the UK would encourage investment and innovation by facilitating the extension of the Applicant's FTTP broadband network to selected locations in other parts of the UK. The provision of such a network would promote access to very high capacity networks and encourage the availability of a wide range of communications services, including high-speed data transfer services. In our view this would also help support the future development, growth and availability of modern communications services in the public interest.
- 3.22 We also consider that the Applicant's intended network extension could also enhance competition and customer choice as the Applicant proposes to offer retail services in competition with existing telecoms providers and to provide wholesale services to other telecoms providers.
- 3.23 The effect of implementing the proposal is likely to be low. Any costs to those affected by the Applicant's use of Code powers are likely to be outweighed by the benefits. On the other hand, the detrimental effect on the Applicant of a refusal to modify its Code powers (including to the practicability of its proposed network extension) is likely to be significant. We are also of the view that the effect of our proposal is not likely to be to the detriment of any protected group within society.

#### **Proposal**

- 3.24 Having considered the Applicant's application, we propose to modify the terms on which the Code applies to the Applicant so that the Code should have effect in its case for the provision by the Applicant of an electronic communications network, throughout the whole of the United Kingdom.
- 3.25 We consider that our proposal is appropriate having regard to the considerations set out in sections 107(4) and 115(4A) of the Act. We consider that the performance of our statutory duties in sections 3 and 4 of the Act would be secured and furthered in relation to this proposal.
- 3.26 We will consider any responses we may receive by the closing date before making our decision as to whether we should give a further direction modifying the terms on which the Code is applied to the Applicant.

The overview section in this document is a simplified high-level summary only. The proposals we are consulting on and our reasoning are set out in the full document.

### A2. Ofcom's consultation principles

# Ofcom has seven principles that it follows for every public written consultation:

#### Before the consultation

A2.1 Wherever possible, we will hold informal talks with people and organisations before announcing a big consultation, to find out whether we are thinking along the right lines. If we do not have enough time to do this, we will hold an open meeting to explain our proposals, shortly after announcing the consultation.

#### **During the consultation**

- A2.2 We will be clear about whom we are consulting, why, on what questions and for how long.
- A2.3 We will make the consultation document as short and simple as possible, with a summary of no more than two pages. We will try to make it as easy as possible for people to give us a written response. If the consultation is complicated, we may provide a short Plain English / Cymraeg Clir guide, to help smaller organisations or individuals who would not otherwise be able to spare the time to share their views.
- A2.4 We will consult for up to ten weeks, depending on the potential impact of our proposals.
- A2.5 A person within Ofcom will be in charge of making sure we follow our own guidelines and aim to reach the largest possible number of people and organisations who may be interested in the outcome of our decisions. Ofcom's Consultation Champion is the main person to contact if you have views on the way we run our consultations.
- A2.6 If we are not able to follow any of these seven principles, we will explain why.

#### After the consultation

A2.7 We think it is important that everyone who is interested in an issue can see other people's views, so we usually publish all the responses on our website as soon as we receive them. After the consultation we will make our decisions and publish a statement explaining what we are going to do, and why, showing how respondents' views helped to shape these decisions.

## [*Proposed*] Direction under section 106(3) of the Communications Act 2003 applying the electronic communications code

#### **Background**

- **1.** The Applicant was granted Code powers, under a direction given by Ofcom on 22 October 2019, for the purposes of the provision by the Applicant of an electronic communications network in England.
- **2.** The Applicant has applied to Ofcom for the grant of Code powers to cover the rest of the UK and, for this purpose, has requested a modification of the terms on which the Code currently applies to it.
- **3.** The date on which Ofcom received a completed application that meets the statutory requirements with respect to the content of an application for a direction applying the Code and the manner in which such an application is to be made was 12 May 2021.
- **4.** By virtue of regulation 3 of the Electronic Communications and Wireless Telegraphy Regulations 2011 (SI 2011 No. 1210), except in cases of expropriation, Ofcom must make its decision within 6 months of receiving the completed application.
- **5.** Prior to giving a decision under section 106(3) of the Act to apply the Code to the Applicant, including giving a further direction to modify the terms on which, by virtue of section 106(5) of the Act, the Code applies to the Applicant, Ofcom must publish a notification of its proposal to give the direction and consider any representations about that proposal that are made to Ofcom within the period specified in the notification.
- **6.** On 11 June 2021, Ofcom published a notification in accordance with section 107(6) of the Act of its proposal to give a further direction applying the Code to the Applicant on specified modified terms. That notification invited representations to Ofcom by no later than 5pm on 12 July 2021.
- **7.** [Ofcom has considered every representation about the proposal made to it/Ofcom did not receive any representations about the proposal]. For the reasons set out in the explanatory statement accompanying the above mentioned notification, Ofcom has had regard, in particular, to each of the matters set out in section 107(4) of the Act. Furthermore, Ofcom has considered and acted in accordance with section 115(4A) of the Act, its general duties in section 3 of the Act and the six requirements in section 4 of the Act.

#### **Decision**

- **8.** Ofcom hereby directs, in accordance with section 106 of the Act, that the terms on which the Code applies to the Applicant by virtue of section 106(5) of the Act under its existing direction given by Ofcom on 22 October 2019, shall be modified as follows—
  - (a) the Code shall continue to apply to the Applicant for the purposes of the provision by the Applicant of an electronic communications network;
  - (b) the restriction of the application of the Code on the Applicant to England shall be removed; and
  - (c) the application of the Code to the Applicant shall now have effect throughout the United Kingdom.

**9.** This Direction shall take effect on the day it is published.

- 10. In this Direction—
  - (a) "Act" means the Communications Act 2003;
  - (b) "Applicant" means Jurassic Fibre Limited, whose registered company number is 11427267;
  - (c) "Code" means the electronic communications code set out in Schedule 3A to the Communications Act 2003;
  - (d) "Ofcom" means the Office of Communications.
- **11.** For the purpose of interpreting this Direction—
  - (a) headings and titles shall be disregarded;
  - (b) the Interpretation Act 1978 shall apply as if this Notification were an Act of Parliament.
