

Satellite (non-geostationary earth station) temporary licence application form

In this application, Starlink Internet Services Limited, a subsidiary of SpaceX, is requesting a temporary licence for authorisation to access E-band spectrum (in addition to the current Ka band licence) at the existing Woodwalton non-geostationary (NGSO) gateway site, which is already licensed (the existing Ka band licence is 1293303).

The E-band frequencies that Starlink is requesting are: 71-76 GHz (space-to-Earth) and 81-86 GHz (Earth-to-space).
