Additional comments:

Many contracts include the purchase of the handset. Customers exiting a contract due to price rises should pay a fixed fee to retain the handset if this occurs in the first 9 months of the contract. The fee should be two months contract payment.

Providers increasing costs part way through a contractual period is the equivalent of a customer entering a contract for a given amount, then telling the provider that they will not pay the agreed amount but will pay less. And inviting the provider to buy out the remaining term of the contract if the provider no longer wants them as a customer at the reduced rate.
