Additional comments:

Have two £13.00 per month 2 year contracts with '3' due to expire June 2013. Received their advice mid 2012 that the contract price was to rise to £13.45p.m. from July 2012 for the remainder of the contract.

I objected strongly on the basis that we both 'made a contract' for two years and I have stuck to my part of the deal, the least they can do is stick to theirs. I understand they are covered in the small print of the contract - but to me it is 'underhand'and 'sneaky'. If they say its £13pm for two years it should stay at £13pm for two years.

Won't renew with them on maturity though - as a matter of principle!

I agree - the customer should definitely have the right to terminate without penalty. I do not agree that Providers should be allowed to do this.

No. The consumer should not share the risk - it should be down to the provider to 'do their homework' before the contract is offered.

Yes - I agree harm is caused to the consumer
