Additional comments:

AT ALL TIMES THERE SHOULD BE AN OVERRIDING REQUIREMENT TO REACT QUICKLY TO INTERFERENCE ISSUES ESPECIALLY FOR VULNERABLE PEOPLE. THIS IS PARTICULARLY SO WHERE LARGE NUMBERS ARE RESIDENT IN CARE HOMES OF VARIOUS SIZES AND CONDITIONS. EXPERIENCE INDICATES THAT MANY OF THESE MAY NOT ENJOY THE BEST POSSIBLE RECEPTION CONDITIONS ANYWAY (OFTEN WITH MORE THAN A SINGLE AMPLIFIER/SYSTEM OPERATING WITHIN THE HOME) AND WILL CERTAINLY REQUIRE URGENT REACTION TO ISSUES RAISED.
