Question 1: Do you think that allowing Now Digital to extend the coverage area of its Exeter & Torbay local radio multiplex licence to include North Devon would unacceptably narrow the range of DAB programme services available in the Exeter and Torbay area? Please explain the reasons for your view.:

Yes, because there is a only finite amount of relavent service and information one radio station can provide to listeners within a given area. By attempting to provide a service to North Devon they will be reducing the service that Exeter and Torbay receive. If it did not, that would indicate that North Devon would not be receiving a fair share of the service.
