These proposals give the impression that North Devon will just been tacked-on to this multiplex. The proposed coverage is unfairly poor for the 30% who will not be able to receive these services. Radio listeners in North Devon have not been carefully enough considered, in that they will have significantly less of a service than the rest of the country-including even the rest of Devon.

These proposals are unsatisfactory and unfair for radio listeners in North Devon. If current FM broadcasting serves nearly the entirety of the population, it seems ridiculous to potentially reduce the service to 70%- were FM to be switched off.
