In recent days Heart has advertised in the local papers and has had lots of "local" material in the papers. They have now been broadcasting "local" news bulletins for the area. So surely that is an admission of guilt.

Now of course what this will be doing will be accepted by OFCOM as following the local guidelines.

This is simply not good enough.

In your own report: http://stakeholders.ofcom.org.uk/binaries/research/radio-research/digital-radio-reports/report210710.pdf you state that OFCOM have the responsibility to sufficient pluraity of broadcasters to an area. If this proposal goes through then we may have a pluarity oin DAB. However the term "LOCAL" is a mockery. What local stations do we get. Kiss, Gold, NME, Capital and others - all which are now National. This does not offer any more local radio to North Devon that identifies with North Devonians

The report further states that OFCOM have to encourage effective competition. How will allowing the DAB proposals go through allow effective competition. This will enable Global Radio broadcasting as Heart to gain an automatic renewla for 7 years unchallenged this first time. They will probably only have to install 1 of the proposed DAB transmitters duirng this time and will be able to portray themselves falsely as LOCAL radio for North Devon. So do we have to support the campaign for a further 7 years until the licence becomes available again

The same report states an appropriate amount of local material should be broadcast on each local licence. The effect of the closure of the Barnstaple office has been that less local information is given out

The local tourist industry and event holders are now cancelling their events due to lack of public awareness

Only today, Wednesday 29th June, the Bideford Folk Festival has cancelled their major event in 2011 due to lack of interest and ticket sales.

This is one area where local radio can be backing such events and integrating orally on air about such events and encouraging participation

Instead we get staid presentation and repeptitive music from London that in no way conforms to the local guidelines laid down in your own rules - http://stakeholders.ofcom.org.uk/broadcasting/radio/localness/localness-guidelines

Your own title states you are an Independent regulator and competition authority for the UK communications industries.

This consultation is going to be a sham.

The whole problem with your consultation on DAB in North Devon is that it is not the real question that people want to answer. Now is the time OFCOM should stand up and prove yoursleves to be a true unbiased adjudicator. Now is the time for OFCOM to say enough is enough - to halt the decline of local radio in the UK and enable the North Devon people their wish

To have a local radio based in North Devon - to provide new jobs and investment into the area, to recognise that North Devon , Barnstaple, Bideford and the other towns in the area are not affiliated to Exeter or Plymouth. The traffic on the M5, the traffic in Newton Abbott and the Tor Point ferries have no bearing on our every day lives.

If a listener in Leeds was to hear traffic information about Manchester would they call that local? What about Oxford traffic in Birmingham?

These proposals have been hasilty put together by Global and Now Digital in order to do one thing and one thing only - not to care about the infastruture in Digital - Ashley Tabor himself said he didnt want to invest in digital until more funding was found by the BBC - but purely a cynical and calculated application to get an extension of the analogue licence thus protecting their business plan and their idea that a national radio station is what they want to make Heart

I throughly oppose the extension of DAB. Using your own rules, guidelines and reports OFCOM you really have no choice.

If this decsion is granted then you might as well allow every other request that GMG, Bauer or Global request. You may as well allow them to alienate many listners across the country and as a n organisation you will be left tainted and open to accusations of collusion with the radio groups. Rather than protecting the industry you will simply be protecting yourself
