Allocation of 116 numbers

- Ofcom is consulting on adding 116006 and 116117 to the National Telephone Numbering Plan. The former is proposed to be a Freephone number for a helpline for victims of crime service and the latter free-to-caller nonemergency medical on-call service. BT set out its thoughts on the policy issues around the introduction of 116 numbers in its response to Ofcom's 2008 consultation on the subject. Ofcom published its statement in February 2009.
- 2. BT notes the proposals in the current consultation. We assume that the commercial arrangements for originating calls to 116117 will be in line with other 116 and free-to-caller numbers. In the case of 116006, we assume that the arrangements will be in line with the majority of 080 numbers which are Freephone.
