DRM is, generally and specifically, awful. It restricts user choice (interoperbility becomes a sham when the interoperable devices are a drastically limited subset of 'approved' devices chosen by the board). It is vulnerable to removal of service at the whim of the DRM provider (a number of DRM content providers have already proved an example of this when they arbitrarily decide the service does not fir their current business model, and cust the service, leaving users with unviewable / unlistenable content).
