The outcome of this exercise has potentially fatal consequences for members of the general public. In general, I agree with the idea of making various parties pay an appropriate amount of use of the spectrum. However, there needs to be exceptions made for users that supplement the professional emergency services.

The RNLI and Mountain Rescue teams save lives in circumstances where the emergency services simply cannot help. Furthermore, these organisations are mostly dependent on people putting their spare change in the box on the bar to run. Any increase in their spectrum subscriptions will mean that there would be less money for that training exercise or that piece of equipment that will be used to get someone to safety. For example, if the Cairngorm MR Team hadn?t have turned up in 2004, there would have been 39 dead school children. These organisations make a difference.

A simple exemption scheme for these services such that they pay a peppercorn rent for their small slice of spectrum will have a big positive effect on them and minimal effect on the financial aims of this proposal. Given the long-standing reluctance of the government to provide support to these organisations, this would be a small, but significant gesture.

It would be heartening to see some humans making a decision instead of an accounts ledger.
