I am very concerned about BSkyB?s proposals to withdraw its three channels on Freeview and to replace them with three subscription channels.

Over 9 million households in the country have purchased Freeview boxes and receive their television services by this mode. This figure will increase as the Digital Switch over programme proceeds between now and 2012. Sky?s proposals will inevitably make Freeview less attractive and could undermine the switch over exercise and the considerable sums of money, which are being invested to upgrade and adapt the transmitter network throughout the country. At the same time, is promoting its own

alternative (Freesat), which is its current form is far less attractive. Sky?s proposals seem to be a cynical attempt to undermine Freeview and promote its own alternative.

The existing DTT Pay TV services provided by Top UP TV and Setanta utilise a single CAM, which is plugged into an appropriate socket in the Freeview box or IDTV. If Sky?s submitted proposals are approved it would not be possible to receive its subscription channels and those provided by Top UP TV and Setanta, which would cause confusion for the general public and mean that it would be necessary to purchase two boxes to receive all the channels. Ultimately, this could undermine the position of the Top Up TV and Setanta, and reduce the level of choice available. If Ofcom, decides to sanction Sky?s proposals, it should insist that it should be via a single CAM.
