Question 1:To what extent do you consider that DTT, DSat, cable and IPTV are in competition with one another for subscribers of pay TV services? either at present or in the future?:

Currently the main competition is between cable and DSat - DTT is only marginally involved in pay TV

# Question 2:To what extent do you consider the Proposal is likely to deliver benefits to the consumer?:

No benefits. Given that Sky already own one of the major platforms (DSat) it seems unnecessary for them also to start delivering pay channels on DTT. Surely a better model would be to keep DTT for free channels and allow anyone who wants pay TV to subscribe to satellite or cable. This is likely to be detrimental to the majority of the population who aren't interested in pay TV since the there will be competition for capacity on DTT which will reduce the number of free channels.

Question 3:To what extent do you consider that there is scope for sustainable competition in pay TV on the DTT platform and, more broadly, across all pay TV platforms?:

Very little on DTT due to capacity limitations.

As I said above, genuine competition is likely to be very limited. We should be more worried about the anti-competitive aspect of Sky getting involved in another pay TV platform.

I think that the big danger with this proposal is the start of a migration of the freeview services to pay per view. This would be very detrimental to the majority of viewers who do not want to pay a subscription.
