I think they are in competition with each other.

Question 2:To what extent do you consider the Proposal is likely to deliver benefits to the consumer?:

I thibnk it will make SKY channels available to those unable to install a satellite dish (eg rented flats) and no access to cable.

Question 3:To what extent do you consider that there is scope for sustainable competition in pay TV on the DTT platform and, more broadly, across all pay TV platforms?:

They need to be compatible - have a single viewing card to prevent having to insert a different one for different channels.

## Additional comments:

I have no objection to loosing Sky 3 and Sky Sports News. However, to remove Sky News from free DTT would reduce the provision of News on DTT - there would be no competition to BBC News 24. I would rather permission was granted to allow Sky to use 2 channels not 3, keeping Sky News in MPEG 2 viewable by all. It is not good keeping it but changing compression to MPEG 4, as no existing equipment would receive it. So, please keep Sky News free to air on DTT.
