Question 2:To what extent do you consider the Proposal is likely to deliver benefits to the consumer?:

I believe that the proposal will only lead to benefits to the consumer if the proposer uses systems which are already being used on DTT. By this I mean that there should be direct competition on DTT between Top Up Tv, Setanta and Sky. People should be able to choose which service they want and pick between without the additional cost of having to change set top box. Consumers should be able to choose to subscribe to all services with only one box needing to be required.

For there to be true competition on DTT, consumers need to be able to switch between services much easier, i.e. use the same equipment for different services.
