Question 1:To what extent do you consider that DTT, DSat, cable and IPTV are in competition with one another for subscribers of pay TV services? either at present or in the future?:

DSat and Cable are in limited competition due to Cable's lack of overall penetration. DTT as a platform has no chance of competing with DSat or DCable due to lack of bandwidth. IPTV is a non-starter with the current ISP "fair" usage limits.

Question 2:To what extent do you consider the Proposal is likely to deliver benefits to the consumer?:

No benifits to consumers.

Question 3:To what extent do you consider that there is scope for sustainable competition in pay TV on the DTT platform and, more broadly, across all pay TV platforms?:

As the DTT channels now compete with each other very well, converting three of those channels to pay TV will reduce competition.

Three pay TV channels on DTT offers no competition to the tens of worth watching pay TV channels on DSat and DCable.
