**Question 1: To what extent do you consider that DTT, DSat, cable and IPTV are in competition with one another for subscribers of pay TV services ? either at present or in the future?:**

There is limited capacity on DTT and what capacity there is should be used for FTA services as far as is practicable. Pay TV does better to use the cable and satellite platforms where there is sufficient capacity to truly allow for competition.

Absolutely none at all. It is depriving the consumer of access to services.
