Question 1:To what extent do you consider that DTT, DSat, cable and IPTV are in competition with one another for subscribers of pay TV services? either at present or in the future?:

To the extent that the competing companies are ultimately going to restrict channel space for possible channels. The purpose of Freeview is to allow viewers the opportunity to view free channels, and as the tv market becomes increasingly competitive, then surely there may be more tv companies who wish to broadcast channels free. Having pay tv (with the exception of TopUpTV as this organisation

does not restrict vieweing space and does not offer anything other than than downloaded tv content at an affordable price) will undermine the beauty of freeview.
