Question 1:To what extent do you consider that DTT, DSat, cable and IPTV are in competition with one another for subscribers of pay TV services ? either at present or in the future?:

There is good competition already. I already resent some Freeview channels being only available on payment.

Question 2:To what extent do you consider the Proposal is likely to deliver benefits to the consumer?:

I don't. My choice would be restricted by any removal of the three free to air (FTA) channels that Sky currently provides on the digital terrestrial television (DTT) platform.

Question 3:To what extent do you consider that there is scope for sustainable competition in pay TV on the DTT platform and, more broadly, across all pay TV platforms?:

There is already sufficient competion. Sky, Virgin & Tiscali already compete. Picnic can only be introduced by sacrificing current Freeview choice.
