

Question 1: Do you agree with Ofcom's proposal to exempt users of Citizen's Band (CB) radio (and other related applications such as Community Audio Distribution) from the need to possess a Wireless Telegraphy Licence.: I think that there should be a licensing system, however along the lines of the proposed new Amateur Radio Licence, they should be on-line free-issue for a long period of time, perhaps 10 years, with the licensee updating his/her details online to renew.

Question 2: Do you agree with Ofcom's proposals to permit the use of 'Micro' FM transmitters in the UK, and to authorise that use by licence exemption.: Yes, although the power levels and frequencies allocated should be harmonised across Europe to prevent interference. The power levels should be high enough to offer a good quality signal however not be so high as to cause interference to users in other cars or nearby static listeners. The frequencies chosen should be reserved for such devices and provide a sufficient cushion either side of the frequency to prevent interference from adjacent Broadcast stations.

Question 3: Do you agree with Ofcom's proposals to exempt users of High Density Fixed Satellite Services (HDFSS) terminals from the need to possess a Wireless Telegraphy Licence.: Yes.
