## Your response

Question 1: Do you agree with Ofcom's proposal to remove the list of larger parties from Section Six of the Code and the PPRB Rules? Give reasons for your answer.:

We support the proposal to remove the concept of "larger parties" from the Code. We have previously highlighted the comparative position of the Liberal Democrats in Scotland and the Scottish Green Party. The Liberal Democrats had "larger party" status at the 2016 Scottish Parliament elections, while the Scottish Green Party did not. The Scottish Green Party, as most had expected, achieved a greater share of the regional vote in May 2016 and had more MSPs elected than the Liberal Democrats. It was effectively only as a result of public opinion that we had debates between the Scottish leaders of all political parties likely to gain representation at the election. I doubt if broadcasters were assisted in coming to that welcome result by a Code which

provided for a simple list of larger parties.

The proposed amendments all appear appropriate to deal with BBC Charter Renewal. On reviewing this section of the Code, it is noted that the Political Parties, Elections and Referendums Act 2000 only applies to referendums which take place as a result of legislation in the UK Parliament. The referendum on Scottish Independence took place on the authority of the Scottish Independence Referendum Act 2013, an Act of the Scottish Parliament. A draft Bill has been published by the Scottish Government for a future referendum. The 2013 Act was heavily modelled on the 2000 Act. The draft Bill extensively applies the 2013 Act. It is suggested that the reference to the 2000 Act is removed but that a reference to "statutory" is inserted before "UK-wide" to cover both referendums under the 2000 Act and other referendums based on the provisions in the 2000 Act.
