Statutory requirements

The request was AGREED, because Ofcom was satisfied in relation to Section 106(1A)(a) of the Broadcasting Act 1990 (as modified by the Community Radio Order 2004, and further modified by the Community Radio (Amendment) Orders 2010 and 2015) i.e. that the change would not substantially alter the character of the service, and for the policy reasons given below.

The licensee is proposing to make a reduction in its original output requirement from 15 hours per day to nine hours per day, a reduction of 40%. The Licensee wishes to make this change to better reflect the volunteer resources it has available, and it says it will take some pressure off the station's management team while they seek to recruit more volunteers and presenters. The Licensee aims to improve its provision of original output over time as it recruits new presenters.

Ofcom is satisfied that this change will not substantially alter the character of the programme service provided by Corby Radio, and that the licensee will be able to continue to meet its overall Key Commitment to be "an informative, relevant and entertaining community radio station to the target community" regardless of the reduction in original output hours. An original output requirement of nine hours per day is not unusually low for a community radio service, and should not hinder the Licensee's ability to provide social gain to its target community through the provision of the on-air service. We are also encouraged to see that the Licensee is already in the process of actively recruiting new presenters and volunteers, so that it will be able to increase its original output offering over time.

In terms of our policy criteria, Ofcom is satisfied that the change will not affect the station's ability to meet the community radio 'characteristics of service' set out in the legislation, and for the reasons set out above, we judge the extent of the impact of the change on the character of service to be small. We have therefore decided to exercise our discretion to approve this change.
