1. Overview

The purpose of this form

- 1.1 You should complete this form if you are applying for a licence to provide a small-scale radio multiplex service (a 'small-scale radio multiplex licence'). A small-scale radio multiplex service is the means by which DAB digital radio stations ('digital sound programme services') are broadcast, and can transmit around ten stereo digital sound programme services (or a significantly higher number if the DAB+ standard is utilised). The application form is divided into two parts Part A (which we will publish on our website) and Part B (which will be kept confidential). This document constitutes Part A; Part B of the application form is available separately.
- 1.2 Small-scale radio multiplex licences are awarded by Ofcom in a competitive process. Applications are judged against specified criteria, and Ofcom awards the licence to the applicant which it considers best meets the criteria.

How to complete the form

- 1.3 There are detailed instructions on how to complete this form, and information on the next steps in the application process, in our <u>guidance notes</u> for licence applicants and licensees. Please read this guidance and the frequently asked questions carefully before completing this form.

East Antrim Community SSDAB Limited T/A Ards Community SSDAB is a partnership between 3 FM Community Radio Stations, Belfast 89 (Belfast FM Limited), Blast106 (Blast106 Limited) and Sunshine 1049 (Sunshine 1049 Limited) and a DSP Licence Holder Blast 106 Digital Limited which are based in the neighbouring polygon but which all have broadcast areas within or over lapping the polygon.

We have been working on the Ards Peninsula polygon since it was first advertised on the first occasion. Unfortunately, the loss of our main transmitter site on that occasion shortly before the close of applications made it impossible to submit at that time. This preparatory work has been informed by the experience of those involved having brought the successful Lagan SSDAB multiplex to air and with the invaluable knowledge that that has brought, both technically and operationally.

Our brief is to provide good quality indoor and outdoor coverage around the advertised polygon in a way that is logistically viable; respects the parameters laid down by Ofcom in terms of overspill and protecting specific polygons; recognises the population densities; and is economically sustainable.

This is a difficult polygon to cover while respecting the parameters and having a multiplex that can be financially viable given the population densities.

Accordingly, we are applying with a single transmission site which best meets these requirements. However, we are happy to consider the addition of another site to the south of the polygon should our application be successful if Ofcom desires that. The southern part of the polygon is not part of the Ards Peninsula and does not connect to the rest of the polygon and is part of Newry, Mourne & Down District Council and might actually be better included in the Newry Multiplex.

We are not seeking to significantly serve area outside the polygon and have been careful in our technical planning not to do so. To achieve this we have chosen to use directional antennae to minimise overspill and yet maximise coverage within the polygon.

In our planning we noted that areas around Carryduff, Saintfield Ballynahinch and Holywood could be subject interference from small-scale DAB multiplexes that may already be on-air or may come on air.

We have tried to ensure that our outgoing interference is minimised especially with regards to the Ballymena small-scale polygon and toward Scotland and the Isle of Man by choosing directional antenna and we believe we have achieved this in so far as it is possible and the possible detriment to our own coverage.

We have also been cognisant of interference into the Republic of Ireland which now has its own DAB+ trial running (Failte DAB) and we have taken great care to protect and prevent interference/coverage towards the Republic of Ireland

Subject to availability of frequencies, impact on neighbouring polygons and financial viability we are happy to work with Ofcom to provide additional in-fill transmitter installations or increase/decrease power as required or desired by Ofcom to improve and increase coverage of the polygon should Ofcom be minded to award the Mux to us.


We feel we have successfully planned to help mitigate any negative effects from ACI to other DAB multiplexes in the area and to other co-channel multiplex polygons further afield.





3.17 Please provide a high-level estimate of the costs you believe will be required to establish the multiplex service.

Our projections are based on our real world experience of having brought Lagan SSDAB to air across Greater Belfast and having operated that multiplex and knowing the costs involved. We have also through this involvement become aware of better priced suppliers and have an increased ability to do contra-deals for equipment and services.

Capital investment for transmitter, filter and antenna at £6,000.00. There are no site works required.

Installation of antenna by Gordon Miskimmin £150

Our Site costs monthly are £150 plus £25 for broadband.

Electricity usage is metered but our experience of the Lagan SSDAB site at White Mountain would be £85-100 per month.

Cost of Commissioning will be £500 to Ulstermux who have the necessary equipment and experience.

We already have a secure cabinet for holding the equipment within the transmitter site Block-build building.

There is no additional site rental costs and our technical services and multiplexing is carried out on a contra-deal for carriage.

Evidence of current cash funding at bank has been provided in the Appendices.

Once the Mux is launched, day-to-day ongoing operating costs will be met through renting capacity on the multiplex to third parties. Accounting for a free period of 3 months for all services on air at launch, the Mux will be financially self-sufficient from Month 3 onwards.

The applicant, East Antrim Community SSDAB Limited, is owned and run by experienced operators of Ofcom licensed Radio services and Transmission installations in the region area who are familiar with the costs of set up and operating transmission facilities.

The management of the multiplex, including its technical start-up, will be contracted to Ulstermux Limited through John Gartlan. They will be responsible for the day-to-day technical management of the multiplex under the supervision of the Directors. Ulstermux Limited has established an effective management and ownership platform for SSDAB operations.

All administrative, finance, compliance and regulatory functions will be managed by the company directly, to ensure it achieves it aims of serving our CDSP and DSP Service Providers and benefitting the local community.

Our proposed carriage fees are set at a level such as not to be a barrier to services participating in the Mux while at the same time ensuring that the running costs can be met and re-investment in the Mux can be made.

In line with our community ethos, it is proposed that the Reserved Capacity CDSP spots will be provided Free of Charge.

East Antrim Community SSDAB Limited is a community owned not-for-profit company limited by guarantee. Any surplus generated by the Mux will be used as follows:

- 1. Reinvestment in the Mux.
- 2. To create a fund for training and development initiatives in the radio sector with a specific emphasis on the community radio sector.

As such the consortium have unrivalled experience in the operation of low power transmission services in the region, and unlike many commercial radio stations, community radio stations generally self-manage their own transmission facilities which gives our consortium first-hand knowledge invaluable to the successful operation of this Multiplex.

In addition, the directors were responsible for launching Lagan SSDAB serving Belfast & Lisburn so have the proven track record for bringing these projects to fruition.

The directorship of East Antrim Community SSDAB Limited T/A Ards Community SSDAB is made up of designated representatives of the 3 individual community radio stations and the DSP which own the company. In appointing these directors, great thought was put in to ensuring that their skills were complimentary to enhance the management of the company to ensure the success of the multiplex.

Sean Og Mac Braoin (Director)

Sean Og Mac Braoin is perhaps the most experienced community radio practitioner in Northern Ireland. He has been involved in the application, launch or management of 6 stations here and has designed many systems, procedures and training courses used in the management and operation of community radio stations including the manual 'Community Radio – 90% Community 10% Radio'.

An alumnus of Edinburgh Napier University, University of Ulster and Durham University his dissertation studying the impact of Community Radio on Community & Youth Work in Northern Ireland.

He guest lectures to 3rd level students as well as supporting other community radio stations with whom he hasn't been involved and is a keen enthusiast of the expansion of community radio and diversity amongst stations.

Career wise he is a company director and owned a successful group of promotion & marketing businesses in Ireland and Great Britain with clients globally. He is Chairman of The Irish Trust, an Irish-American Charity which funds initiatives on both sides of the Atlantic.

Sean Og's role will to be to maintain the necessary statutory and regulatory records and ensure reports and returns are made as necessary and regulatory compliance is maintained.

Sean Og was responsible for the launch of Lagan SSDAB and manages the daily operations of that multiplex.

Joseph McCormack (Director)

Joseph McCormack, has been involved in the provision of Business Training Services, Business Consultancy and the publication of training materials and other business literature over the past 30 years. He specialises in helping small and medium sized businesses gain competitive advantage from their existing IT and telecommunications resources and the business has particular expertise in the area of remote working, internet applications and the mentoring of small businesses in e-business techniques. Prior to his current consultancy role, Joe was a marketing and sales professional with BT in Northern Ireland for almost 20 years.

He was a founder Director of Townsend Enterprise Park Ltd from 1993 until 2016 and served three terms as Chair and twice as Finance Director.

Training and post training one to one mentoring services have also been provided to InvestNI, Irish Rugby Union Professionals Association (IRUPA), Donegal County Enterprise Board, Meath County Enterprise Board, Monaghan Local Enterprise Office and Cavan Local Enterprise Office together with many of Northern Ireland's Local Enterprise Agencies.

He has also worked on programmes for Belfast City Council, Lisburn City and Castlereagh Council, Armagh Banbridge and Craigavon Council, Derry and Strabane Council and InterTradeIreland.

Efficiency, attention to detail and collegiate personality make Chris the perfect Board member, able to work with people from all walks of life. He is also generous with his time, broadcasting on numerous stations, acting as Head of Volunteering at Blast106 (responsible for recruitment, induction, training & mentoring) and most recently he has been assisting with workshops with a community radio group in Armagh who are at the start of their journey.

Over almost 20 years, his knowledge of the community radio sector in Belfast is unparalleled and his networks among people in the sector is invaluable to the Board. Chris key role within the Board will be liaison with the Service Providers (both CDSP and DSP).

If awarded the multiplex licence, East Antrim Community SSDAB Limited would plan to provide a CDSP on the multiplex which would be a shared community facility/channel for community organisations, youth groups, festivals and events to host their own community radio station for up to 28 days at a time (similar to the old short term RSL licences on FM). The service would be non-competing with any other CDSP or DSP on the multiplex. This channel would also host an annual Christmas-themed station for kids of all ages from 0-100.

We have effectively been working on our preparations for this application since when it was first advertised the first time. We had to pull our application at the last minute for Ards due to the loss of a site.

As part of that we contacted a large number of prospective Service Providers resulting in the Confirmation and the Heads of Terms Agreements. These are attached by way of Appendices. The Heads of Terms outline the proposed rate card.

In addition, the proposed service was publicised on Radio Today, a major industry website and more locally featured on the news bulletins of local community radio stations and an on-air promotion campaign was also run on stations.

When readvertised in January we did interviews on Blast106 and Lagan Radio.

We issued Press Releases a copy of which is in the Appendix marked Fair & Effective Competition.

We will have a website which is currently under creation as of the date of application but will be live before the application is assessed to ensure that all information about the mux will be publicly available.

The only Ofcom licensed Community Radio Station in the area is Sunshine 1049 as Bangor FM appears to have closed but we have attempted to contact them and have provided evidence of this in the Appendix.

Our experience in being involved in Lagan SSDAB serving Greater Belfast we have demonstrated a completely open approach to all Service Providers even those who would be considered to be in competition to the community radio stations which own that Mux. We will take a similar approach with the Ards Mux.

We also believe that pricing for carriage is very important for fair & effective competition so that the cost of carriage cannot be a barrier to accessing the Mux. Naivety in pricing has resulted in some Muxes in the UK struggling to attract services. That is why we have proposed that our Reserved Capacity spots will be free and we are offering both commercial and non commercial DSP spots at a low cost to encourage participation. This is achievable because we are not-for-profit and we are maintaining a low cost base, something that the 3 FM community radio stations have been successful in doing over the past decade and more.
