## Description of character of service

West Kent Radio will improve the health and wellbeing of the 45+ age group within the combined areas of Tunbridge Wells, Tonbridge, Southborough and immediately surrounding neighbourhoods and villages. It will do this by promoting the benefits of living a healthy lifestyle and the importance of maintaining good personal, mental and physical health, by encouraging lifestyle improvements and promoting the services of organisations providing relevant services.

## The service broadcasts:

- Music. The main types of music broadcast over the course of each week are: Music from the sixties to the present day, with album tracks, classical, specialist and live music, biased towards a lighter style
- Speech. The main types of speech output broadcast over the course of each week are: News, information, features, advice, interviews and phone-ins, presented in a friendly and engaging way with content designed to encourage and promote good health and wellbeing.
- The service provides original output<sup>1</sup> for a minimum of 70 hours per week.
- The service provides locally-produced output<sup>2</sup> for a minimum of 112 hours per week.

The studio is located within the licensed coverage area.

The service provides a range of community benefits (social gain objectives mandated by statute) for the target community, both on-air and off-air, and in doing so, achieves the following objectives:

- the facilitation of discussion and the expression of opinion,
- the provision (whether by means of programmes included in the service or otherwise) of education or training to individuals not employed by the person providing the service, and
- the better understanding of the particular community and the strengthening of links within it.
